THE CITY OF BELLBROOK WILL PERFORM THE INITIAL INSTALLATION TO ASSURE THE PROPER OPERATION OF THE FIRE HYDRANT. THE FIRE HYDRANT MUST BE OPENED AND CLOSED SLOWLY. WHEN IN USE, IT MUST BE IN THE FULL OPEN POSITION. THE FIRE HYDRANT MUST BE CLOSED WHEN NOT IN USE, WHEN NO ONE IS ON LOCATION, AND DURING THE OVERNIGHT HOURS. PERIODIC INSPECTIONS MAY OCCUR. IT IS RECOMMENDED THAT YOU REMOVE THE METER ASSEMBLY DURING THE OVERNIGHT HOURS. YOU ARE RESPONSIBLE TO RETURN THE METER ASSEMBLY TO THE UTILITY BILLING OFFICE. VIOLATION OF THESE TERMS MAY CAUSE FORFEITURE OF THE DEPOSIT.
