January 6, 2019 – 0139 hours

Officers responded to a business on East Franklin Street on the report of an altercation. Investigation revealed that a 25-year old male from Bellbrook had started a fight and was highly intoxicated. The suspect would not comply with the officers' orders. The suspect was taken into custody and transported to the Greene County Jail for Disorderly Conduct by Intoxication.

January 6, 2019 – 1700 hours

An officer was dispatched to Streamview Court on the report of a male subject walking in the area with a machete. The officer did locate a male subject matching the physical description of the subject in question. The subject was not in possession of any weapon. The surrounding area was checked but no other subject was located.

January 6, 2019 – 2011 hours

A resident on Marcia Drive reported that he had paid for some merchandise at a business on State Route 725 with a \$50.00 bill. The business manager told him that the money was counterfeit. The complainant advised that the \$50.00 bill was received as change from a business on Wilmington Pike less than a half hour prior to the incident. The counterfeit bill was turned over the police department.

January 7, 2019 – 1723 hours

A traffic hazard was reported on Lakeman Drive. A large tree limb was obstructing the roadway. Officers cleared the roadway.

January 8, 2019 - 0203 hours

A resident on Regent Park Drive reported that she believed an ex-boyfriend hacked her phone and also gained access to her mother's bank account. There was no proof of the allegations. The complainant was given advice to protect her identity and advised to have her mother keep an eye on her bank account. Report taken.



January 8, 2019 – 0610 hours

An unwanted person was reported on Portage Path. The complainant advised that her exboyfriend, a 28-year old male from Miamisburg had arrived at her residence to pick up some property. The property was returned to him without any issues. The complainant did want the subject removed from her property. A criminal trespass warning was issued to the suspect.

January 8, 2019 – 2152 hours

An officer was dispatched to Pinegrove Drive for a welfare check on a 7-year old child. Contact was made with the father who invited the officer inside the residence to check on the child. The child was taking care of her homework and there were no issues. The information was relayed to the mother who had requested the welfare check.

January 10, 2019 – 0403 hours

A domestic dispute was reported on Old Pepper Bend Drive. Upon arrival a male subject was on foot walking away from the residence with some clothing. Some property inside the residence was destroyed. Both subjects were spoken with. The report was forwarded to the prosecutor who declined charges. The male subject was escorted back to the residence the next day to pick up the rest of his belongings while officers stood by. The subject was then criminally trespassed from the residence.

January 10, 2019 – 1334 hours

A domestic dispute was reported on Beechwood Drive. Investigation revealed that a couple from Springfield had gotten into a verbal argument over a text message the female had received on her phone. The dispute had been verbal in nature without any physical violence. Report taken.

January 10, 2019 – 1705 hours

Officers were dispatched to Upper Hillside Drive on a burglary alarm activation. Contact with the homeowner revealed that there was no problem at the residence.



January 10, 2019 - 1926 hours

A resident on Locus Bend Drive reported that her employer had informed her that an unknown subject had e-mailed their finance department and attempted to change the bank account information for the complainant's automatic check deposit. The accounting department intervened after suspecting a fraud. The complainant was not out of any money. Report taken.

January 11, 2019 – 1239 hours

An officer assisted the Kettering Police Department with an attempt to locate a vehicle on Ryder Court that had been involved in a hit/skip accident in Kettering. The vehicle was located and a Kettering Police Officer responded to Ryder Court to issue the driver a traffic citation.

January 12, 2019 – 1310 hours

Officers were dispatched to Ryder Court on a juvenile problem. Investigation revealed that a 16-year old male had punched a hole in a wall after being in a verbal argument with his mother. All parties were spoken with and the mother was given information about filing Unruly Juvenile charges in Greene County Juvenile Court if she decides to take that course of action.

January 12, 2019 – 1708 hours

An officer assisted the Bellbrook Fire Department by providing traffic control while they removed a tree from power lines. The officer stood by until no longer needed.
