January 13, 2019 - 1108 hours

An officer assisted the Sugarcreek Township Police Department with an arrest of a disorderly subject at a business on Wilmington Pike. The officer cleared when no longer needed.

January 14, 2019 – 0249 hours

Officers were dispatched to Beryl Drive on the report of suspicious noises. The complainant advised he believed someone had walked around his home and also knocked on his front door. The perimeter of the home was checked and no one was located. There were no footprints in the deep snow that would indicate someone had been on the premises.

January 14, 2019 – 1042 hours

A traffic accident was reported on West Franklin Street near Little Sugarcreek Road. A vehicle traveling Westbound struck a vehicle that was stopped for traffic. A domestic dispute was reported on Sugarcreek Drive. Investigation led to the arrest of a 45-year old male from Bellbrook for Domestic Violence, Assault, and Child Endangerment.

Officers were dispatched Beryl Drive on a burglary alarm activation. The inside and exterior of the home were checked without any issues. False alarm.
