January 20, 2019 - 0117 hours

Officers responded to South Linda Drive on the report of a vehicle that slid off the roadway. A neighbor assisted and got the vehicle back on the road.

January 20, 2019 – 0941 hours

Investigation of a vehicle that had slid off the roadway on Whites Drive led to the arrest of the driver. Drugs were located inside the vehicle. The 18-year old male who was impaired was cited into Xenia Municipal Court for Operating a Vehicle under the Influence, Drug Abuse, and Failure to Control.

January 21, 2019 – 2149 hours

A business on State Route 725 reported that a customer had tried to pay with a counterfeit \$20.00 bill. The suspect who was located advised that he had received the money from a friend and did not know it was fake. Report taken.

January 22, 2019 – 1352 hours

A traffic stop on West Franklin Street for an equipment violation that the driver did not have a valid driver's license. The 43-year old male from Liberty Township was cited for Driving under Suspension and Expired Registration.

January 22, 2019 – 2032 hours

A dog without a collar or tags was located at the police department. The canine was transported to the Greene County Animal Control shelter in Xenia.

January 23, 2019 – 0203 hours

A resident on Beechwood Drive reported seeing a subject outside of her residence. The perimeter was checked without any indication of anyone having been in the area. The snow on both sides of the house were undisturbed. The findings were relayed to the complainant.



January 23, 2019 - 1542 hours

Officers assisted the Bellbrook Fire Department with traffic control during a chimney fire on North Linda Drive. The officers remained on scene until no longer needed.

January 24, 2019 – 1235 hours

An officer responded on the report of a female passed out behind the wheel of her vehicle parked at a business on West Franklin Street. Contact was made with the driver who advised she had felt sick but would be ok. She denied needing a medic.

A burglary alarm activation was reported on Mission Lane. The interior and exterior of the residence did not reveal any signs of criminal activity.

An officer stopped a vehicle on State Route 725 for equipment violations. An open can of beer was located inside the vehicle that a 49-year old male passenger from Miamisburg claimed to be his. The passenger was cited for Open Container in a Motor Vehicle. The driver was given warnings for Cracked Windshield and No License Plate Light.

January 26, 2019 – 1330 hours

A hit/skip accident was reported on North Linda Drive. The complainant advised she had parked her vehicle and upon returning she found a large dent and marks on the front right wheel. There are no suspects at this time. Accident Report taken.



January 26, 2019 – 1708 hours

A vehicle was stopped on North Main Street for a speed violation. Upon contact with the driver, the officer could smell a strong odor of marijuana coming from the vehicle. The driver, an 18-year old male from Dayton told the officer he had smoked marijuana an hour ago. Drugs and drug paraphernalia were found inside the vehicle. The suspect was checked for impairment but found to be ok. The male was cited into Xenia Municipal Court for Drug Abuse, Possession of Drug Paraphernalia, and Speed.
