January 27, 2019 – 0858 hours

Officer responded to Fowler Dr. on a lockout request. The officer was able to gain access to the locked vehicle without incident.

January 27, 2019 – 1637 hours

A soliciting complaint was called in by a Mill Pond resident. The solicitor was gone upon our arrival. We did not have any other complaints.

January 28, 2019 – 0701 hours

While on patrol, an officer found the lights on inside Penn Station. Upon further investigation, it was discovered that an employee was sleeping inside the business. Officers gained access to the business spoke with the employee and made contact with the store manager. The employee was given a ride back to his residence in Bellbrook.

An officer responded to Rosecrest Dr on an alarm. Upon arrival the exterior of the residence was found to be secure. The homeowner arrived on scene and an interior garage door was found open. The residence was checked and all was secure.

January 829, 2019 – 1241 hours

An officer was dispatched to Shell gas station on a lockout request. An officer arrived and made successful entry into the locked vehicle.

She also noticed shoe prints that went from the tracks to the garage door key pad. She looked at the surveillance footage and noted at 0356 hrs. a dark colored car pulls in and a black male exits. The male walks to the garage door key pad and knocks several times. The male, after a few seconds, walks back to his car and now he has something in his hand that resembles a small piece of paper. The car then leaves. Extra patrol was requested for her residence and the homeowner will call again if there are any other incidents.
