#### December 30, 2018 - 1836 hours

A hit/skip accident was reported in the parking lot of a business on State Route 725. The suspect vehicle fled the scene but was later located with heavy driver side damage and a flat front tire. The suspect, a 24-year old male from Bellbrook was found to be intoxicated. The suspect was arrested and charged with Operating a Vehicle while under the Influence and Reckless Operation on Private Property.

#### December 31, 2018 – 2152 hours

An officer was dispatched to North Main Street on a traffic hazard. A large tree limb was blocking traffic. The officer was able to remove the tree limb from the roadway.

#### **December 31, 2018 – 2337 hours**

An officer responded to Little Sugarcreek Road where a vehicle had struck a tree that was in the roadway. The vehicle had become stuck on top of the tree and had to be towed from the scene.

#### January 1, 2019 – 0015 hours

A complaint of fireworks was received on Von Hovel Court. Upon arrival the officer spoke to the responsible parties who advised they would not set off any more fireworks.

## January 1, 2019 – 0049 hours

Fireworks were reported on South East Street. An officer checked the area but was unable to locate the source.

#### January 1, 2019 – 0129 hours

While on routine patrol an officer located a vehicle on South East Street with heavy damage due to a large tree limb that had fallen on the hood of the car. The owner was contacted and a report was taken for insurance purposes.



## January 1, 2019 – 0540 hours

Officers were dispatched to the 4200 block of West Franklin Street on the report of a suspicious vehicle. Officers checked the area but were unable to locate the vehicle.

## January 1, 2019 - 0819 hours

An officer was flagged down by a resident who was walking on Barnett Drive near Marcia Drive and had found a cellular phone on the roadway. The owner of the phone was located and the property was returned to him.

A verbal dispute between roommates was reported on Ryder Court. Both parties denied that there had been any physical violence. Report taken.

The vehicle was moved the following day.



## January 3, 2019 – 1407 hours

An officer stopped a vehicle on South Main Street for a speed violation. Investigation revealed that the 22-year old male driver from Dayton did not have a valid driver's license. The suspect was cited into Xenia Municipal Court for Driving under Suspension and Speed.

#### January 3, 2019 – 2319 hours

An alarm was reported at a business on East Franklin Street. The building was found to be secure. A key holder was contacted.

### January 4, 2019 – 1746 hours

A subject involved in door-to-door sales was reportedly on Regent Park Drive. An officer checked the area but was unable to locate the subject.

## January 4, 2019 - 1823 hours

Menacing was reported on West Franklin Street. The complainant advised that a male from Bellbrook had made threats against her through communicating them to her son. This had happened before Thanksgiving. The prosecutor was contacted and charges were denied. The suspect, a 47-year old male from Bellbrook was trespassed from the West Franklin Street address.

A safe was found on the side of the roadway in the Vineyards, about 50 feet west from Little Sugarcreek Road. The safe was transported to post. A check for reported stolen safes was completed with negative results. Report taken.
