#### March 3, 2019 – 0959 hours

Officers were dispatched on a complaint of an abandoned vehicle with flat tires on West Maple Street that had not been moved for several months. The vehicle owner was contacted and ordered to have the vehicle removed from the roadway. A check the next day revealed that the vehicle was no longer there.

#### March 4, 2019 – 1348 hours

Officers checked the welfare of an elderly female who had called 9-1-1 several times. Investigation revealed that the female had attempted to contact out of state family and was not dialing the area code correctly.

#### March 4, 2019 – 1758 hours

A parent requested a welfare check of a 5-year old child who was with the custodial mother. Investigation revealed the child was fine.

#### March 6, 2019 – 1334 hours

An officer was dispatched to Ryder Court on the report of two subjects involved in door-to-door sales. Both subjects were told to obtain a solicitor's permit before returning to the area.

## March 6, 2019 - 1640 hours

A traffic stop was conducted on Little Sugarcreek for a vehicle with expired license plates since July, 2017. Contact with the 26-year old female driver from Kettering revealed that her driver's license was also expired since July, 2017 and that she was driving under a license suspension. The suspect was cited into Xenia Municipal Court for all three violations.

#### March 6, 2019 – 1706 hours

A resident on Mill Run Lane reported being harassed by text messages and on social media by a subject known to her. The suspect was contacted and ordered to refrain from contact with the complainant.
