March 10, 2019 – 1317 hours

A dog was found and turned over to the police department. The owner was located and the animal returned.

March 11, 2019 – 1826 hours

An officer was dispatched to the parking lot of a business on State Route 725 where a man from Corwin had locked his keys in his vehicle. The officer was able to gain entry into the vehicle.

March 11, 2019 – 2257 hours

OnStar notified the police department of a possible domestic dispute occurring in a vehicle parked at a business on State Route 725. Investigation revealed that there was a small child crying in the vehicle, and that there was no other problem. A passenger in the vehicle, a 20-year old male from Bellbrook was found to be in possession of marijuana. The suspect was cited into Xenia Municipal Court.

March 12, 2019 – 0709 hours

Officers were dispatched to a business on State Route 725 for an intrusion / tampering alarm activation. Investigation revealed that an employee accidentally had set off the alarm.

March 12, 2019 – 1349 hours

A female on Mill Run Lane reported that she had been receiving threats from an ex-boyfriend in New York. A report was taken so that the complainant can obtain a protection order through the state of New York.

March 12, 2019 – 1715 hours

An officer stopped a vehicle on West Franklin Street near Little Sugarcreek Road after a routine registration check revealed that the driver did not have a valid driver's license. The suspect, a 39-year old male from Bellbrook was cited into Xenia Municipal Court for Driving under Suspension.



March 12, 2019 - 2109 hours

Officers assisted a female who had locked herself out of her residence on Bonniedale Drive. The officers located an unlocked window through which access to the residence was gained.

March 13, 2019 - 0139 hours

A hit/skip accident was reported in the 3600 block of West Franklin Street where a vehicle had struck a guardrail. The vehicle did not stop after the accident but was located near the downtown area. Investigation revealed that the driver was experiencing a medical emergency and was transported to the hospital.

March 14, 2019 – 1000 hours

A driver's license was found at a business on State Route 725. An officer took possession of the property and located the owner from Beavercreek who advised he will pick up his driver's license.

March 14, 2019 – 1329 hours

A resident on Cabernet Way reported that while he had been on vacation unknown subject(s) had cut down some trees on his property. Report taken.

March 14, 2019 – 2213 hours

An officer stopped a commercial truck on State Route 725 for an equipment violation. Investigation revealed that the 27-year old male driver from Middletown did not have a commercial driver's license. His regular driver's license was suspended. There were two different set of license plates on the truck. Contact was made with the owner of the license plates who advised he had sold the truck to the suspect three months prior. The license plates were seized to be picked up by the owner. The suspect was cited into Xenia Municipal Court for No Operator License, Driving under Suspension, and No License Plate Light. The vehicle was towed from the scene.



March 15, 2019 - 0821 hours

A burglary alarm activation was reported on Beryl Drive. Investigation revealed that the homeowner had accidentally set off the alarm.

March 15, 2019 – 2314 hours

Officers assisted the West Carrollton Police Department with an attempt to locate a resident on Justin Court who had violated a protection order in their jurisdiction. Contact was made with the 37-year old male who freely admitted to the offense. The suspect was taken into custody and picked up by a West Carrollton Police Officer.

March 16, 2019 – 0423 hours

While on routine patrol an officer located an open garage door and a vehicle with doors open on Sullivan Drive. Contact was made with the homeowner who advised he had forgotten to close the doors and thanked the officer.
