March 17, 2019 - 0035 hours

An officer located a suspicious vehicle on North East Street. Investigation revealed that the driver was an Uber driver who was lost and needed directions to a Bellbrook business.

A parking complaint was reported on Chelsea Drive where a vehicle was parked in a designated handicap parking spot. The owner of the vehicle was located and told to move his vehicle.

March 17, 2019 – 2129 hours

Officers were dispatched to a business on State Route 725 for an unwanted person who had been argumentative with other customers. Investigation led to the arrest of a 36-year old female from Bellbrook for Disorderly Conduct by intoxication. The female was cited into Xenia Municipal Court and released to her partner. At 2206 hours officers were dispatched to the female's residence on the report of a domestic dispute. The same female was taken into custody for Domestic Violence and Assault after getting in a physical altercation with her partner. She was transported to the Greene County Jail.

March 18, 2019 – 1515 hours

A hit/skip traffic accident was reported on South Linda Drive. A vehicle traveling southbound on South Linda Drive veered off the roadway and struck a speed limit sign. The unknown driver did not stop. There is no suspect at this time.

March 18, 2019 – 2201 hours

An officer located an open garage door on East South Street. The interior of the building checked secure without any signs of criminal activity. The building was re-secured.
