February 10, 2019 – 1426 hours

An officer assisted the Sugarcreek Township Police Department with a vehicle that had slid off the roadway and struck a mailbox on Lower Bellbrook Road. The officer provided traffic control until no longer needed.

February 11, 2019 – 1004 hours

A burglary alarm activation was reported on Poston Drive. Investigation revealed that the homeowner had accidentally set off the alarm.

February 11, 2019 – 1101 hours

A resident on Upper Hillside Drive reported that a known subject had used his credit card to make purchases at home improvement stores in Bellbrook and Xenia. The victim did not want to pursue charges. Report taken.

February 12, 2019 – 1510 hours

A resident on Wentworth Village Drive reported receiving unwanted phone calls and text messages from an ex-boyfriend. The suspect was contacted and ordered to cease all contact.

February 12, 2019 – 1937 hours

Officers responded to North Regent Park Drive on a burglary alarm activation. The homeowner had accidentally set off the alarm.

February 13, 2019 – 1414 hours

Officers were dispatched to Poston Drive on the report of an open front door. The interior of the home was checked and contact with the homeowner revealed that the wind had blown open the door.

February 13, 2019 – 1726 hours

A traffic accident was reported on North Main Street near Pavilion Lane where a vehicle had struck a deer. Accident report taken.



February 13, 2019 – 1909 hours

A wallet that was found in Centerville was turned in to the Police Department. The owner from Bellbrook was located and the property returned to her.

February 13, 2019 – 2251 hours

An officer stopped a vehicle on West Franklin Street for an equipment violation. Upon contact with the driver the officer could smell an odor of marijuana coming from the vehicle. A search was conducted and marijuana was found inside the vehicle. The 23-year old male suspect from Miamisburg was cited into Xenia Municipal Court for Drug Abuse, Possession of Drug Paraphernalia, and Expired Registration.

February 14, 2019 – 0032 hours

While on routine patrol an officer observed a suspicious vehicle driving slowly and stopping in the middle of the roadway in the area of Maxwell Drive and Nedra Drive. Contact with the driver revealed that he was looking for his lost dog.

February 14, 2019 – 1119 hours

A domestic dispute amongst sisters was reported on Lynlee Drive. Investigation revealed that the incident had been verbal in nature. Both parties agreed to avoid each other until calmed down.

February 14, 2019 – 1530 hours

A resident on South Linda Drive reported that he had received a phone call stating that he had to appear in front of a federal grand jury for federal crimes he had committed. The caller told the complainant that if he did not comply he would be taken into custody by a federal agent. The officer explained to the complainant this was a known scam.

February 15, 2019 – 1457 hours

A traffic accident was reported in the parking lot of a business on West Franklin Street. The involved parties exchanged insurance information. Report taken.

Bellbrook and Sugarcreek Township Officers searched the area of Little Sugarcreek Road for a man who had fallen of the roof of a 2-story home. The man did not know where he was. After a lengthy search the subject was located and transported to the hospital for a leg injury.
