February 17, 2019 – 0025 hours

Officers responded to Beryl Drive on the report of a suspicious noise. The complainant advised he had heard loud knocking on his front door but when he checked there was no one at the residence. Officers checked the exterior and interior of the home but no one was located.

February 17, 2017 – 0110 hours

Officers were dispatched to a business on State Route 725 on the report of an aggressive unwanted person. The complainant, an employee, advised that he had several dealings with the same customer on other occasions. The suspect was identified as a 39-year old male from Bellbrook and criminally trespassed from the business.

February 17, 2019 – 1041 hours

Officers took a report of domestic violence that had occurred during the overnight hours. Investigation led to the arrest of a 46-year old male for two counts of Domestic Violence, two counts of Assault after getting physical with his wife and son. The suspect was transported to the Greene County Jail.

February 17, 2018 – 2236 hours

An officer stopped a vehicle for shortcutting an intersection. Investigation revealed that the 28-year old male driver was intoxicated. The suspect was taken into custody and charged with Operating a Vehicle while under the Influence, and Shortcutting Across Private Property.

February 19, 2019 – 1734 hours

A resident reported that he had worked for a business in Bellbrook during December and his employer still owed him unpaid wages. The complainant was advised this is a civil matter and referred to Small Claims Court.



February 21, 2019 – 1210 hours

An officer was dispatched to the area of Ridgeway Road on the report of two dogs running loose in the area. The animals were located hours later and returned to their owner who was cited into Xenia Municipal Court for Dogs at Large.

February 21, 2019 – 1746 hours

A water leak was reported at a business on West Franklin Street. The owner was notified and the Bellbrook Service Department shut off the water.

February 21, 2019 – 2210 hours

A protection order violation was reported on Mill Run Lane. The complainant advised that the suspect, a 47-year old male had approached her in the parking lot and yelled at her. The suspect was taken into custody and transported to the Greene County Jail.

February 22, 2019 – 2228 hours

A welfare check was requested on a subject who had been in his car outside a business on State Route 725. Contact was made with the driver, a 64-year old male from Centerville, who advised he had stopped at the business to rest after feeling fatigued.
