February 24, 2019 – 0139 hours

An officer stopped a vehicle on West Franklin Street for a moving and equipment violation. The suspect, a 23-year old male from Dayton was impaired. Further investigation also revealed that the driver did not have a valid driver's license. The suspect was taken into custody and cited into Xenia Municipal Court for Operating a Vehicle while under the Influence, Driving under Suspension, Lanes of Travel upon Roadways, and No License Plate Light.

February 24, 2019 – 0427 hours

A burglary alarm activation was reported on Maxwell Drive. Officer learned that the homeowner had accidentally set off the alarm.

An officer assisted the Bellbrook Fire Department with traffic control after two trees had fallen across the roadway on West Franklin Street near Vemco Drive. There was no electrical hazard. The officer stood by until the trees were removed and the road was reopened.
