### April 21, 2019 - 0014 hours

Officers were dispatched to Ridgeway Road on the report of an open garage door. Contact was made with the homeowner who thanked the officers and closed the door.

### **April 21, 2019 – 1646 hours**

Officers were dispatched to a business on State Route 725 for a welfare check on a subject down in the grass. Investigation revealed that the 37-year old male from Bellbrook was in need of medical attention and transported to the hospital.

#### **April 21, 2019 – 2053 hours**

While on bike patrol an officer located an open door at a business at the Bellbrook Plaza. The business checked okay without signs of criminal activity. Contact was made with the owner and the building was re-secured.

### **April 23, 2019 – 1738 hours**

An unwanted person was reported on Ryder Court. Investigation revealed that the subject was the complainant's roommate who had paid her rent through May. The complainant was advised that the incident would be documented as a civil matter.

## April 23, 2019 - 1836 hours

A traffic accident was reported at the intersection of West Franklin Street and Little Sugarcreek Road. A vehicle stopped at the traffic light was struck in the bumper after the light changed to green. The driver at-fault, a 24-year old female from Spring Valley was cited into Xenia Municipal Court for Failure to Maintain Assured Clear Distance.

## **April 23, 2019 – 2108 hours**

A resident on Rosecrest Drive reported Identity Theft. The complainant advised that she was notified by her bank that an unknown subject had purchased fuel in the amount of \$129.52 on Needmore Road in Dayton. The bank closed the complainant's account and did not hold her liable for the purchase. Report taken.



### **April 24, 2019 – 1359 hours**

Officers responded to Barnett Drive on a burglary alarm activation. Investigation revealed that the alarm system had malfunctioned.

#### **April 24, 2019 – 1558 hours**

A traffic accident was reported on West Maple Street. A driver had exited her vehicle without placing it in park, and accidentally placed it in reverse instead. The vehicle traveled backwards and struck a parked car. A 36-year old female from Bellbrook was cited into Xenia Municipal Court for Unattended Motor Vehicle.

#### **April 24, 2019 – 1723 hours**

A burglary alarm activation was reported at a business on State Route 725. Upon arrival the officers located an open door. The building was checked. There were no signs of criminal activity. The owner responded to lock the business.

#### **April 25, 2019 – 1201 hours**

An officer assisted the Sugarcreek Township Police Department with traffic control while they handled a traffic accident on Clyo Road.

### **April 25, 2019 – 1254 hours**

A resident on West Franklin Street reported several subjects trespassing through her backyard. The subjects were located and it was learned they were in the area to perform work for a utility company. They were advised to make contact with a homeowner first before entering their property in the future.

## **April 25, 2019 – 1641 hours**

An officer was dispatched to Sugar Leaf Drive where a man from Xenia had locked his keys in his car while his 2-year old child was in the vehicle. The officer was able to gain entry. The child checked okay.



### **April 25, 2019 – 1340 hours**

Officers were dispatched to a residence on Little Sugarcreek Road for a welfare check after the complainant had not been able to get a hold of his relative since the prior day. The Bellbrook Fire Department was dispatched to gain entry into to home where the elderly female was found on the floor. She was transported to the hospital.

#### **April 26, 2019 – 1434 hours**

A 16-year old female was found in the possession of what is believed to be liquid nicotine. The juvenile was released to her parent. The report was sent to the prosecutor to be reviewed for charges.

#### **April 27, 2019 – 1445 hours**

Officers assisted the Bellbrook Fire Department with a residential fire on Nedra Drive. The cause of the fire is undetermined at this time.
