April 28, 2019 – 1315 hours

Officers were dispatched to West Maple Street for a domestic dispute. Investigation led to the arrest of a 19-year old female from Miamisburg for Domestic Violence, Assault, Resisting Arrest and Disorderly Conduct after physically assaulting her 21-year old boyfriend. The suspect was arrested and transported to the Greene County Jail.

April 28, 2019 – 1820 hours

An officer responded to a business on West Franklin Street on the report of two unwanted subjects. The complainant advised that he had warned two juveniles on four previous occasions about skateboarding in his store and parking lot. The officer located a 14-year old male from Kettering who subsequently was cited into Greene County Juvenile Court for Criminal Trespassing.

April 29, 2019 - 0643 hours

Officers responded to Maxwell Drive on a panic alarm activation. Investigation revealed that the homeowner had accidentally set off the alarm.

April 29, 2019 – 1339 hours

A resident on West Franklin Street reported receiving threatening text messages from a person known to him. The suspect was contacted and ordered to cease any contact with the complainant.

April 29, 2019 – 1346 hours

An officer was dispatched to a business on West Franklin Street for an unwanted person. Investigation revealed the complainant was in a heated argument with a disgruntled exemployee. The suspect, a 26-year old male from Bellbrook was criminally trespassed from the property.



April 30, 2019 - 0830 hours

A barking dog complaint was received on Kensington Drive. The dog owner was contacted and informed of the complaint. The resident advised she would address the matter.

April 30, 2019 – 0923 hours

An officer stopped a vehicle on Wilmington-Dayton Road after a routine registration check revealed that the male driver from Centerville did not have a valid driver's license. The suspect was cited into Xenia Municipal Court for Driving under Suspension.

April 30, 2019 – 1059 hours

Officers responded to a traffic crash at Bellbrook Plaza. A vehicle attempted to pull into a parking spot. The driver failed to apply the brakes and crashed into the front of a business. Report taken.

May 1, 2019 – 0950 hours

A traffic accident was reported on East Franklin Street. A vehicle stopped for a pedestrian walking in a crosswalk was struck by a second vehicle that failed to stop in time. The driver atfault, a 32-year old female from Spring Valley did not have a valid driver's license. She was cited into Xenia Municipal Court for Following Too Close, Failure To Reinstate License, and Expired License.

May 1, 2019 - 1340 hours

A wanted subject fled on foot from an officer attempting to take him into custody. The 32-year old male from Bellbrook was located later that afternoon. The suspect was charged with Resisting Arrest and Obstructing Official Business and transported to the Greene County Jail.

May 2, 2019 - 0932 hours

A hit/skip accident was reported on Wilmington-Dayton Road. A vehicle traveling north ran off the roadway and got stuck in a ditch. The driver was assisted by another motorist and pulled out of the ditch. The vehicle left the scene. No suspect information at this time.



May 3, 2019 - 1050 hours

Officers were dispatched to Plantation Trail where a trash truck had run into overhead wires. A power line and cable line were struck. Utility companies were dispatched for repair. Report taken.

May 3, 2019 - 1602 hours

An officer responded to Upper Bellbrook Road where a female from Xenia had locked her keys in her vehicle. The officer was able to gain entry.

May 4, 2019 – 1603 hours

A telephone harassment report was taken on State Route 725. The complainant advised she had been receiving harassing text messages from a friend. The suspect was contacted and told to stop any communication with the complainant.

May 4, 2019 - 1837 hours

A dog at large was reported on Pond View Court. Upon the officer's arrival the owner was on scene to retrieve his dog. The man explained that the animal had gotten out of his yard by crawling under a broken fence and advised that he would correct the problem.
