**May 5, 2019 – 1427 hours**

An officer stopped a vehicle on Wilmington Pike for a registration violation. Investigation revealed that the 27-year old male driver from Beavercreek was wanted by the Centerville Police Department. The suspect was taken into custody and turned over to a Centerville officer.

**May 5, 2019 – 1957 hours**

A traffic stop was conducted on a vehicle on East Franklin Street for an equipment violation. Investigation revealed that the 68-year old female did not have a valid driver's license. The driver was cited into Xenia Municipal Court for Driving under Suspension and given a warning for Window Tint.

**May 6, 2019 – 0524 hours**

An officer assisted the Sugarcreek Township Police Department with the arrest of an impaired driver on Upper Bellbrook Road. The remained on scene until no longer needed.

**May 6, 2019 – 1436 hours**

A disabled vehicle was reported on South Linda Drive. Upon the officer's arrival it was learned that the vehicle had run out of gas. The officer transported the driver to a gas station and then back to his vehicle.

**May 6, 2019 – 1755 hours**

An officer stopped a vehicle on Lakeview Drive due to having knowledge that the driver did not have a valid driver's license. The 27-year old male from Bellbrook was cited into Xenia Municipal Court for Driving under Suspension.



**May 7, 2019 – 1105 hours**

An officer assisted a man from Dayton who had locked his keys in his car on Moss Oak Trail while his child was in the vehicle. The officer was able to gain entry.

**May 7, 2019 – 2300 hours**

Officers located an open door at a business on West Franklin Street. The building was checked without signs of criminal activity. The building was re-secured and the business owner notified.

**May 7, 2019 – 0815 hours**

A resident on Wentworth Village Drive reported that she had received a phone call from a company that claimed to be selling anti-virus software for her computer. The complainant advised that she noticed the caller had remotely logged into her computer as they were discussing pricing. She proceeded to give the caller her credit card number and after the call was finished she noticed that her account had been charged over \$600.00. She contacted her bank and was eventually refunded the money. The complainant was given advice to protect herself from fraud and identity theft in the future. Report taken.

**May 8, 2019 – 1040 hours**

An officer was dispatched to Springcreek Circle on the report of a dog running loose in the area. The canine had returned back to its' home prior to the officer's arrival. Contact was made with the owner.

**May 9, 2019 – 0800 hours**

A domestic dispute was reported on Possum Run Road. Investigation revealed that the dispute had been verbal in nature. The complainant decided to leave the residence. Report taken.

**May 9, 2019 – 1502 hours**

Officers were dispatched to North Linda Drive for a dispute. Investigation led to a 47-year old male from Bellbrook being cited into Xenia Municipal Court for Disorderly Conduct.



**May 9, 2019 – 1605 hours**

A school bus driver reported two violations of vehicles passing the bus while it was stopped on East Franklin Street to unload children. Both suspects were located. A 77-year old male from Wilmington was cited into Xenia Municipal Court and a 17-year old female from Bellbrook was cited into Greene County Juvenile Court for Failure to Stop for a School Bus.

**May 9, 2019 – 1758 hours**

An officer stopped a vehicle after learning that the driver was wanted by the Montgomery County Sheriff's Department. The suspect, a 35-year old male from Bellbrook was transported to the Greene County Jail to await extradition.

**May 9, 2019 – 2030 hours**

A traffic accident was reported on Main Street. A vehicle traveling southbound applied the brakes causing a vehicle that was following to collide with it. The driver at-fault, a 17-year old male from Bellbrook was cited into Greene County Juvenile Court for Failure to Maintain Assured Clear Distance Ahead.

**May 10, 2019 – 0011 hours**

A report of suspicious persons with flashlights was received on Washington Mill Road. Investigation revealed that the subjects were competing in a sport event.

**May 10, 2019 – 1428 hours**

An officer was dispatched to Barnett Drive on the report of a subject involved in door-to-door sales. The subject was located and ordered to cease his activity and informed of the City requirement to have a solicitor permit.



**May 10, 2019 – 2102 hours**

A vehicle was stopped on Wilmington-Dayton Road for a registration violation. Upon further investigation a drug pipe with residue was located inside the vehicle. The driver, a 26-year old male from Kettering was cited into Xenia Municipal Court for Possession of Drug Paraphernalia and Expired Registration.

**May 10, 2019 – 2349 hours**

An officer observed a vehicle stopped in the middle of the roadway on Main Street. After conducting a traffic stop on the vehicle investigation revealed that the driver was impaired. An open beer, a drug pipe, and two bags of marijuana were located inside the vehicle. The suspect, a 57-year old female from West Carrollton was taken into custody and charged with Operating a Vehicle while under the Influence, Drug Abuse, Possession of Drug Paraphernalia, Possession of an Open Container, Rules at an Intersection, No Turn Signal, and Left of Center. The suspect was transported to the Greene County Jail.

**May 11, 2019 – 0207 hours**

An officer assisted the Sugarcreek Township Police Department with the arrest and booking of a disorderly subject. The officer remained on scene until no longer needed.

**May 11, 2019 – 2055 hours**

A traffic stop on West Franklin Street for a moving violation led to the driver, a 25-year old male from Illinois being cited into Court for Speed and Driving under Suspension.

**May 11, 2019 – 2321 hours**

An officer stopped a vehicle on West Franklin Street for an equipment violation. Investigation revealed that the 27-year old male driver from Spring Valley did not have a valid driver's license. He was cited into Xenia Municipal Court for Driving under Suspension and given a warning for Two Brake Lights required.
