May 19, 2019 – 0308 hours

Officers were dispatched to Upper Hillside Drive on the report of two boys ringing doorbells. The juveniles were located and spoken with about their actions. They were sent home.

May 19, 2019 – 0457 hours

An officer observed a suspicious vehicle on West Franklin Street at Little Sugarcreek Road parked at a green traffic light for an extended period of time. Contact was made with the 34-year old male driver who advised he was lost. The officer gave him directions to get to his destination.

May 20, 2019 – 0830 hours

A theft of jewelry was reported by a couple who had used a moving company to move from Beavercreek to Sugar Run Trail. The case was assigned to a detective and the investigation is ongoing.

May 22, 2019 – 1258 hours

An officer was dispatched to the area of Poston Drive on the report of subjects who were involved in door-to-door sales. The group was located and advised to cease their activity and explained that they could not solicit sales without a permit. All subjects left the area.

May 22, 2019 – 1611 hours

Officers responded to a business on East Franklin Street on the report of an unwanted person. Contact was made with the highly intoxicated 37-year old male suspect from Texas, who was criminally trespassed from the business.

May 22, 2019 – 2010 hours

An officer was dispatched to Brewsters Run Court on the report of a male subject involved in door-to-door sales. The suspect was located and ordered to cease his activity and explained how to obtain a solicitor permit.



May 23, 2019 – 1436 hours

A physical fight between juveniles was reported on West Franklin Street. A 12-year old male and a 13-year old male from Bellbrook were cited into Greene County Juvenile Court for Disorderly Conduct.

May 23, 2019 – 2037 hours

An officer stopped a vehicle on West Franklin Street for an equipment violation. Investigation revealed that the 43-year old male driver from Dayton did not have a valid driver's license. The license plate on the vehicle was stolen. The owner picked up the license plate. The suspect was cited into Xenia Municipal Court for Driving under Suspension and Driving with License Plate of Former Owner.

May 23, 2019 – 2133 hours

Officers were dispatched to Mill Pond Drive to perform a welfare check on a female who had left her car running for two hours. Contact with the female revealed that she had fallen asleep but was okay.

May 24, 2019 – 1436 hours

A domestic dispute was reported on West Maple Street. Investigation revealed that a neighbor had heard loud yelling coming from a residence but no altercation had taken place.

May 24, 2019 – 1702 hours

An officer stopped a dump truck on Wilmington-Dayton Road for an equipment violation. Investigation revealed that the driver was driving under a suspended Ohio license, and had no valid out of state license. The suspect, a 33-year old male from Cincinnati was cited into Xenia Municipal Court for Driving under Suspension, and No Driver's License.



May 24, 2019 – 1858 hours

An officer stopped a vehicle on Wilmington-Dayton Road for an equipment violation. Upon approach of the vehicle the officer could smell a strong odor of marijuana coming from the vehicle. A large amount of marijuana, in the form of candy, vape oil, and in a mason jar was located inside the vehicle in addition to two drug scales. The driver, a 33-year old male from Vandalia was found to be impaired. He was cited into Xenia Municipal Court for Operating a Vehicle while under the Influence, Drug Abuse, Drug Paraphernalia, and Window Tint. A 35year old male passenger from Waynesville also had drugs in the vehicle and admitted to smoking marijuana 30 minutes prior. He was cited into Court for Drug Abuse.

May 24, 2019 – 2333 hours

Officers were dispatched to Shiraz Court for a holdup alarm. Contact was made with the homeowner who advised his daughter had accidentally set off the alarm.

May 25, 2019 – 1819 hours

A holdup alarm activation was reported on Marcia Drive. Upon contact with the resident it was learned that there was no problem and it was a false alarm.
