## June 2, 2019 – 1254 hours

A report of a dog running loose was received on Rosecrest Drive. The animal was located by an officer and contact was made with the owner who was issued a warning for Dog at Large.

## June 3, 2019 – 0027 hours

A resident on South Lakeman Drive reported receiving harassing phone calls and text messages. The suspect from West Carrollton was located and ordered to cease all contact with the complainant.

#### June 3, 2019 – 0121 hours

A welfare check was requested on a 15-year old female whose father had not been able to make contact with her. The female was staying with friends on Beechwood Drive with permission from the other parent and there was no problem. This information was relayed to her father.

## June 3, 2019 – 0739 hours

Officers responded to Chelsea Drive on the report of a broken car window. The complainant advised that nothing was missing from the vehicle. Report taken.

## June 4, 2019 – 1041 hours

While on routine patrol an officer was approached by a female on East Franklin Street. The female requested a welfare check on a relative who was walking towards the downtown area after an argument had occurred. Contact was made with the subject in question who advised that family tensions had been running high at a residence on South Main Street where she had been staying temporarily. She advised she was in the process of moving into a new home.



## June 4, 2019 - 1554 hours

An officer was dispatched to Crescent Court on a loud music complaint. Upon arrival the officer could hear loud music coming from a vehicle. Contact was made with the owner who was told to turn down the music.

## June 4, 2019 – 1722 hours

A traffic accident was reported on South Main Street. A driver whose vehicle was parked on West Franklin Street started his vehicle, causing it to roll backwards and striking a building on South Main Street. Report taken.

## June 5, 2019 – hours

A report of a dog running loose was received on Beechwood Drive. Upon arrival the officer made contact with a neighbor who had confined the dog in her yard. Contact was made with the dog owner's mother who promptly retrieved the animal. The owner was issued a warning for Dog at Large.

#### June 6, 2019 – 0423 hours

An officer patrolling the Sugar Bell Plaza on State Route 725 observed an occupied running vehicle in the parking lot. A man was found sleeping behind the wheel. Upon waking the male subject it was clear that the subject was intoxicated. The 26-year old male from Springfield, Illinois was taken into custody and cited into Xenia Municipal Court for Physical Control.

## June 6, 2019 – 0925 hours

A neighbor dispute over a Facebook post was reported on Lower Hillside Drive. The complainant felt that he had been threatened. Upon review of the Facebook comments there were no threats made. A report was taken to document the complainant's concerns.



#### June 6, 2019 – 1155 hours

An officer responded to the parking lot of a business on West Franklin Street where a female from Bellbrook had locked her keys in her vehicle. The officer was able to gain entry into the vehicle.

## June 6, 2019 – 1324 hours

A report of two dogs running loose in the area of Lower Hillside Drive was received. Officers checked the area but the animals were not located. Greene County Animal Control was dispatched and they eventually found the canines later in the evening. The owner was issued two citations by Greene County Animal Control.

#### June 6, 2019 – 1441 hours

A resident on Tampico Trail reported that he had locked his keys in his vehicle. An officer was able to assist and gained entry into the vehicle.

#### June 6, 2019 – 1822 hours

A parking problem was reported on North Regent Park Drive. An unlicensed trailer was parked in the roadway. Attempted contact with neighbors was unsuccessful. A check later in the evening revealed that the trailer which was now properly licensed had been moved.

## June 6, 2019 – 1922 hours

A burglary alarm activation was reported on Caudell Drive. An officer checked the residence which was secure. A notification was left for the homeowner.

## June 6, 2019 – 1959 hours

An officer observed a motorcycle crash on Feedwire Road. A vehicle had failed to yield to the motorcycle and turned in front of it causing an accident. The officer stood by until the Sugarcreek Township Police Department arrived.



## June 6, 2019 - 2114 hours

An officer stopped a vehicle on West Franklin Street at Vemco Drive for a turn violation. Investigation revealed that the 44-year old male driver from Bellbrook was intoxicated. The suspect was cited into Xenia Municipal Court for Operating a Vehicle while under the Influence and Rules for Turns at an Intersection. He was later released to a relative.

## June 6, 2019 – 2130 hours

A hit & run accident was reported on West Franklin Street. The reporting party advised she was traveling Westbound on West Franklin Street when a vehicle traveling the opposite direction with a large piece of wood sticking out of it, struck her vehicle causing damage to the windshield and "A" pillar. The suspect vehicle continued without stopping. Report taken.

## June 7, 2019 – 1924 hours

An officer was dispatched to Justin Court on the report of a subject involved in door-to-door sales. The subject, a 31-year old male from San Diego, California was located and did not have a valid solicitor permit. He was advised the cease his activity until he obtained a permit through the City.
