### June 16, 2019 – 1342 hours

An officer conducted a welfare check on an elderly male who was walking and appeared to be confused. The resident from Marcia Drive advised that he could not find his way home. The officer transported him back to his residence where contact was made with his spouse.

#### June 16, 2019 – 1423 hours

An officer was dispatched to Wilmington-Dayton Road for the welfare check on an elderly man who was laying in the grass. Upon contact, the man from Bellbrook advised he was fine, and just taking a nap.

#### June 16, 2019 – 2054 hours

Officers were dispatched to Barnett Drive on the report of dogs running loose in the area. The animals were located and secured in their backyard. The owner was issued a warning for Dogs at Large.

#### June 16, 2019 – 2228 hours

While on routine patrol an officer located an occupied vehicle at MaGee Park. Contact was made with a 19-year old male and 17-year old female from New Carlisle. Contact was made with the female's parent. The couple was told to leave the park as it was closed.

## June 17, 2019 - 0612 hours

Officers responded to a business on South Main Street on a burglary alarm activation. Investigation revealed that the owner had accidentally set off the alarm.

#### June 17, 2019 – 1603 hours

A traffic accident was reported on Sugar Run Trail. A vehicle traveling south bound struck an unoccupied vehicle. The driver advised he had recently been in a crash with the same vehicle and did not have it repaired yet. He claimed problems with the vehicle caused him to swerve and strike the other vehicle. State Highway Patrol was summonsed to the scene to determine



if the vehicle was safe to operate, which was confirmed. The driver, a 23-year old male from Enon was cited into Xenia Municipal Court for Failure to Control.

## June 17, 2019 – 2045 hours

Officers checked the welfare of an elderly female on Elizabeth Circle after the power outage. The female was okay, and the information was relayed to her daughter.

## June 17, 2019 – 2123 hours

A burglary alarm activation was reported on Woodedge Drive. Investigation revealed that the power outage had caused the system to fail.

#### June 18, 2019 – 2152 hours

Officers responded to Bledsoe Drive on an alarm activation. Investigation revealed that the homeowner had accidentally set off the alarm.

#### June 19, 2019 – 1610 hours

A resident on Bledsoe Drive reported that an unknown subject had opened a PayPal account in his name. The complainant was not out of any money. An officer gave the subject advice about protecting himself from any future identity theft.

#### June 20, 2019 – 0945 hours

A business on West Franklin Street reported that four bad checks had been cashed that were also forged. The report was assigned to a detective.

#### June 20, 2019 – 1056 hours

A resident on Hess Road reported that an unknown male had knocked on her door to ask her for gas money and to use her phone. The area was checked but the subject was not located.



#### June 20, 2019 - 1138 hours

A resident on Lower Hillside Drive reported there was a vehicle parked in front of that was unknown to him. The vehicle had been covered with a blanket, and the side windows were marked that the vehicle was out of gas, and the driver would return soon. Upon further inspection, the vehicle had extensive front end damage. Information was received that the Waynesville Police Department was looking for a vehicle that had fled the scene of an accident and matched the vehicle on Lower Hillside Drive. A Waynesville Police Officer responded to the scene, and had the vehicle towed. Contact was made with the owner who advised he had let a friend drive the vehicle. He did not know the driver's last name.

A subject arrived at the police department to report she had been harassed by a female while at her place of employment on East Franklin Street. The manager requested that the 47-year old female from Bellbrook was trespassed from the business.

## June 20, 2019 - 1521 hours

A resident on Brookwood Drive turned over a wallet he had found. The owner was located and the property was returned to him.

#### June 20, 2019 – 1855 hours

An officer stopped a vehicle on South West Street for several moving violations. The driver was issued a warning for the violations. Investigation revealed a 48-year old male passenger in the vehicle had an active nationwide warrant from Adams County for his arrest. The suspect was transported to the Greene County Jail to await extradition.

#### June 22, 2019 – 0103 hours

Officers were dispatched to Rosecrest Drive on the report of a domestic dispute. Investigation revealed that the dispute had been verbal in nature. The female involved in the dispute left the residence for the evening.
