June 23, 2019 – 0034 hours

Officers were dispatched to the 3700 block of West Franklin Street for a road hazard. A large tree had fallen and was covering the roadway. The Bellbrook Service Department was dispatched and removed the tree.

June 23, 2019 – 0215 hours

While on routine patrol an officer located a vehicle with the rear hatch open. Contact was made with the owner who advised he had forgotten to close it earlier in the evening. He secured his vehicle.

June 23, 2019 – 2026 hours

Officers were dispatched to Upper Hillside Drive on the report of a domestic dispute. Investigation revealed a verbal argument had taken place and the parties separated for the evening.

June 24, 2019 – 0916 hour

A burglary alarm was reported on West Franklin Street. A check with the homeowner revealed that a door had been left unsecured and triggered the alarm.

June 24, 2019 – 1637 hours

A computer scam was reported on Portage Path Drive. The complainant advised she had been contacted by a company who advised that her computer had bad files on it. She was told to buy two \$500.00 gift cards and provide the caller with the numbers on the cards, and the caller would then fix her computer. After providing the caller with the gift card information, the caller told the complainant that the cards did not go through and buy another \$1,000.00 in gift cards. The complainant then decided to file a police report. The complainant's laptop was no longer operational. Report taken.



June 24, 2019 - 2340 hours

Officers were dispatched to Hillrise Drive on the report of a suspicious vehicle traveling through the area. The officers located the vehicle and contact with the driver revealed that the family was looking for their lost dog.

June 26, 2019 – 1133 hours

A subject arrived at the police department to report problems with a previous employer who still owed him money. He also needed to retrieve tools from a job site in Spring Valley. The officer explained that the owed money was a civil matter and to contact the Greene County Sheriff's Department to go with him to retrieve his tools.

June 26, 2019 – 1300 hours

A resident on Liam Court reported telephone harassment by an old acquaintance from Arkansas. The complainant advised that the subject would not stop calling and texting her. The complainant was advised to block the caller's phone number.

June 26, 2019 – 1612 hours

An officer was dispatched to Marcia Drive on a burglary alarm activation. Investigation revealed a relative of the homeowner had accidentally set off the alarm.

June 26, 2019 – 1650 hours

A business owner on West Franklin Street reported that a male subject had come into her store and advised that he had taken a taxi from Pike County to seek help at a clinic in Bellbrook. The subject was located and it was learned that he was supposed to be going to a clinic on Bellbrook Avenue in Xenia. The subject took a taxi back home to Pike County.



June 27, 2019 - 0900 hours

A resident on South Lakeman Drive reported that the front license plate and frame were stolen of her car. The complainant had already replaced the license plate with a new set. A report was taken.

June 27, 2019 – 1301 hours

Officers were dispatched to Nedra Drive on the report of an intoxicated female driver with an infant in the car. The vehicle was backing out of a driveway and drove into a yard across the street when officers arrived on scene. The female then stopped her vehicle in the middle of the roadway and sat in her car. Further investigation led to the arrest of the 25-year old female from Huber Heights for Operating a Vehicle while under the Influence, Child Endangering, and Improper Backing. The infant was picked up by a relative.

June 28, 2019 – 0930 hours

A Mill Pond Drive resident reported that an unknown subject had opened a cellular phone account in his name and owed the company \$1,500.00. A report was taken for the complainant to forward to the company's fraud department.

June 29, 2019 - 1541 hours

A domestic dispute was reported on East Walnut Street. Officers spoke with both parties and it was learned that it had been a verbal argument. The parties separated for the evening.
