### June 9, 2019 - 1025 hours

An officer responded to Beechwood Drive on the report of a dog running loose in the area. The animal was captured by a resident on Clearview Court. The dog did not have a tag, and an owner could not be located. The animal was taken to Greene County Animal Control in Xenia where the owner later claimed it.
