March 31, 2019 – 1309 hours

An officer assisted with moving a disabled vehicle off the roadway on South Main Street. The vehicle was later towed.

April 2, 2019 – 2159 hours

A domestic disturbance was reported on Hess Road. Investigation led to the arrest of a 58-year old male and a 59-year old female for Domestic Violence and Assault. Both subjects were transported to the Greene County Jail.

April 3, 2019 - 0029 hours

An officer assisted the Sugarcreek Township Police Department with a warrant arrest on Wilmington-Dayton Road.

A license plate was found on North Main Street. The owner from Riverside was contacted, and advised he had already obtained a replacement license plate. The found property was destroyed.
