## June 30, 2019 – 0820 hours

Officers responded to Sugar Maple Place on the report of three dogs running loose in the area. The animals were located and returned to their owner who was issued a warning for Dogs at Large.

#### June 30, 2019 – 1937 hours

An officer stopped a vehicle on Wilmington-Dayton Road for an equipment violation. Upon contact with the driver, the officer could smell a strong odor of marijuana coming from the vehicle. A bag with marijuana was located inside the vehicle. The driver was tested for impairment and was found to be under the influence of the drugs. The 18-year old male from Xenia was cited into Xenia Municipal Court for Operating a Vehicle while under the Influence, Drug Abuse, and Improper Vehicle Registration Display.

## June 30, 2019 – 2338 hours

While on routine patrol an officer observed a subject at Bellbrock Park smoke from a bong. Investigation revealed that the subject was smoking hookah. The subject was advised the park was closed and told to leave the area.

#### July 2, 2019 – 2048 hours

An officer stopped a vehicle on State Route 725 for an equipment violation. Marijuana was located inside the vehicle. The 26-year old male driver from Trotwood did not have a valid driver's license. The suspect was cited into Xenia Municipal Court for Driving under Suspension, Drug Abuse, and Window Tint. The vehicle was towed.

# July 3, 2019 - 1722 hours

An officer located a vehicle parked in the middle of the roadway on Vemco Driveway. Investigation revealed that the driver from Springfield was lost. The officer assisted with directions.



## July 4, 2019 – 1232 hours

An officer responded to the parking lot of a business on East Franklin Street where an elderly female from Spring Valley had locked her keys in her vehicle. The officer was able to gain entry into the vehicle.

The complainant advised that her son had been arrested by the Miamisburg Police Department for Public Intoxication earlier in the day. She had bailed out her son and brought him back to Bellbrook. A verbal altercation ensued and the male had left to go to another residence on Upper Hillside Drive. The officers responded to that address and made contact with the 40-year old male. Due to the subject's level of intoxication he was transported to the hospital by the Bellbrook Fire Department.
