July 21, 2019 – 0958 hours

An officer was dispatched to Upper Hillside Drive on the report of a found dog. An owner could not be located, and the dog was picked up by Greene County Animal Control.

July 21, 2019 – 2155 hours

Officers were dispatched to a business on East Franklin Street for a burglary alarm activation. The building checked secure.

July 22, 2019 – 1351 hours

A resident on North Belleview Drive reported being harassed on Facebook by a subject known to her. The complainant advised that she had tried to block any contact from the suspect which had been unsuccessful. The complainant was advised to contact her internet provider to add additional security on her Facebook account.

An intrusion alarm was reported on Pavilion Lane. A key holder was contacted, and officers checked the interior of the residence. There were no signs of criminal activity.

A 9-1-1 hang up call was received from a residence on Beryl Drive. Upon contact with the homeowner it was confirmed that it had been a misdial.

July 22, 2019 – 2227 hours

While on routine patrol an officer located an occupied vehicle at Magee Park. Contact was made with the 16 and 18-year old occupants from Centerville, who were advised that the park was closed. They left the area without incident.



July 24, 2019 – 1720 hours

An officer stopped a vehicle on West Franklin Street for a Speed violation. Investigation revealed that the 24-year old male driver from New Lebanon did not have a valid driver's license. The suspect was cited into Xenia Municipal Court for Driving under Suspension and Speed.

A dispute was reported on East Franklin Street. Investigation revealed that the dispute was a civil matter between a landlord and a prior tenant who was picking up personal belongings. The officers stood by until the tenant left the premises.
