July 28, 2019 - 1719 hours

Officers were dispatched to Hillcrest Drive on the report of a traffic hazard. Upon arrival officers located a large tree that was blocking the roadway. The officers stood by until the Bellbrook Service Department arrived to remove the tree.

July 28, 2019 - 2252 hours

A burglary alarm activation was reported on West Franklin Street. The exterior of the home revealed no signs of any criminal activity and a false alarm was confirmed.

July 29, 2019 – 0943 hours

Officers were dispatched to an alarm activation on Hillrise Circle. Investigation revealed that the homeowner had accidentally set off the alarm.

July 30, 2019 – 1446 hours

A welfare check was requested on a confused elderly female on Firebird Drive. The female was found to be ok, and a relative responded to the home to stay with the subject in question.

July 31, 2019 – 1015 hours

An officer responded to Bledsoe Drive on the report of a domestic dispute. The dispute had been verbal in nature. The case was reviewed by the prosecutor and charges were denied.

July 31, 2019 – 1825 hours

A traffic crash was reported on Wilmington-Dayton Road. A vehicle was stopped for traffic turning onto Ambridge Drive. The vehicle behind it failed to keep a safe distance and struck the stopped vehicle's rear bumper. The 21-year old male driver at-fault was cited into Xenia Municipal Court for Failure to Maintain Assured Clear Distance Ahead.



July 31, 2019 - 2245 hours

An officer assisted the Sugarcreek Township Police Department with traffic control on Centerville Road where a vehicle was parked in the middle of the roadway. The officer stood by until no longer needed.

July 31, 2019 – 2341 hours

Officers responded to Bayberry Cove Drive to assist the Sugarcreek Township Police Department with a fight in progress. Upon arrival investigation revealed that no fight had taken place. All officers cleared the scene.

August 1, 2019 – 1110 hours

An officer was dispatched to a business on State Route 725 where a female from Bellbrook had locked her keys in her vehicle. The officer was able to gain entry into the vehicle.

August 1, 2019 – 1130 hours

A welfare check was requested on male subject who was on foot on West Franklin Street, limping without any shoes on. The subject advised he had just been released from the hospital and was walking to his home in Spring Valley. The officer offered to give him a ride which he denied.

August 2, 2019 – 1012 hours

Officers were dispatched to Knob Hill Drive on the report of subjects involved in door-to-door sales. Upon arrival two male subjects from Springfield were located. They did not have a Solicitor's permit and were advised to leave the area. The passenger in the vehicle leaving the area was observed a half hour later driving on State Route 725. It was known that he did not have a valid driver's license. The officers stopped the vehicle and cited the 37-year old male into Xenia Municipal Court for Driving under Suspension.



August 2, 2019 - 1420 hours

An officer responded to Eckworth Drive where a Bellbrook resident had locked his keys in his vehicle. The officer was able to gain entry.

August 3, 2019 – 0613 hours

Officers responded to a business on State Route 725 for a burglary alarm activation. Upon arrival officers located an open back door. The business was checked but there were no signs of any criminal activity. A key holder was notified and the building locked.
