#### August 4, 2019 – 0242 hours

While on routine patrol an officer discovered an open garage door on Lynnlee Drive. There were no signs of criminal activity. Contact was made with the homeowner who closed the door.

#### August 4, 2019 – 1923 hours

An officer was dispatched to Washington Mill Road where a female from Kettering had locked her keys in her vehicle. The officer was able to gain entry.

#### August 5, 2019 – 1032 hours

Officers were dispatched to Cedar Court on a burglary alarm activation. Investigation revealed that the homeowner had accidentally set off the alarm.

## August 5, 2019 – 1722 hours

An officer was requested to check the welfare of a male juvenile sitting on a guardrail on Little Sugarcreek Road. The male advised he was okay and taking a walk while waiting for his mother return home. No problem.

## August 6, 2019 – 2230 hours

Officers were dispatched to Lakeview Drive on the report of domestic violence between two juveniles. Investigation revealed no physical violence had occurred. Report taken.

# August 7, 2019 – 0528 hours

Officers were dispatched to Sugar Maple Place on a burglary alarm activation. The exterior of the home checked okay. Contact was made with the homeowner who requested that the interior of the residence was checked. There were no signs of any criminal activity.



#### August 7, 2019 - 1739 hours

Officers were dispatched to Bellemeade Drive on a welfare check request. Upon arrival the officer made located the homeowner sitting on the ground. The male advised he had just been released from the hospital and could not get into his home as his keys were inside the residence. An officer was able to gain entry to the home and let the resident inside his house.

### August 8, 2019 – 0913 hours

An officer stopped a vehicle for an equipment violation. Investigation revealed that a 29-year old male passenger was wanted on an active warrant from the Greene County Sheriff's Department. The suspect was taken into custody and turned over to a Greene County Sheriff's Deputy. The driver was given a warning for Improper Display.

### August 9, 2019 - 0519 hours

While on routine patrol an officer located an open door at a business on State Route 725. The business checked secure. A notice was left for the owner who could not be reached.

### August 9, 2019 – 0742 hours

A burglary alarm was reported at a business on West Franklin Street. The business checked secure.

# August 9, 2019 – 2004 hours

An officer responded to North Linda Drive on the suspicious vehicle. Upon arrival it was learned that the vehicle was left in the parking lot due to a flat tire.

## August 10, 2019 – 0845 hours

An officer was dispatched to Regent Park Drive to check the welfare of an elderly female resident after a relative had been unable to contact her. The female was found to be okay, and the message was relayed to contact her relative.



#### August 10, 2019 - 1329 hours

A traffic accident was reported on West Franklin Street. A vehicle traveling Westbound came to a stop for a vehicle in front of it. A vehicle following behind it was unable to stop in time and rear ended the other vehicle. The 20-year old driver at-fault from Xenia was cited into Court for Failure to Maintain Assured Clear Distance Ahead.

#### August 10, 2019 – 1707 hours

A resident on Brookwood Drive reported that she had received mail from a cellular phone company stating she owed them over \$3,000.00. According to the company it was tied to a bogus account. The account's phone numbers belong to subjects in Eaton and Cincinnati. A third phone number did not reveal an owner. The complainant was informed by the cellular phone company she is not responsible for the bill. Report taken.

### August 10, 2019 - 1716 hours

An officer was dispatched to Fowler Drive on the report of a suspicious person loitering in the area. Investigation revealed that the 38-year old male from Fairborn was painting house numbers on the curb and was involved in door-to-door sales. He was advised he needed to cease his activity until he obtained a solicitor permit.

## August 10, 2019 – 2344 hours

An officer was approached by a female on foot on Wilmington-Dayton Road. She advised that she had locked her keys in her vehicle at a business on State Route 725. The vehicle also had a flat tire. The female did not have a valid driver's license. The officer gained entry to the vehicle and stood by until the female was picked up by a friend.
