August 19, 2019 - 0727 hours

An officer responded to Brookwood Drive on the report of a 9-1-1 hang up call. Investigation revealed that a small child had been playing with the telephone.

August 19, 2019 – 1504 hours

Officers were dispatched to Lynlee Drive on a report of domestic violence. Upon arrival officers met with the victim who advised the 19-year old male suspect from Dayton had left on foot. The male was located on Wilmington Pike a short time later and taken into custody. The suspect was charged with Domestic Violence and Assault and transported to the Greene County Jail.

August 19, 2019 – 1902 hours

An officer responded to Mill Pond Drive for a parking problem. Upon arrival the complainant advised that someone was parked in a handicap parking space. The owner of the vehicle was located and told to move the car.

August 21, 2019 - 1031 hours

A resident on East Carmella Court reported a fraud. The complainant advised her son had tried to sell shoes online for \$150.00. The victim was contacted by a potential buyer and the price was agreed upon, and the buyer would be mailing a check to the victim's home. The victim then received a check in the amount of 1,980.00 and was told to cash the check and to deliver the shoes the buyer's courier. This is when the victim's mother contacted the police department. The complainant was advised this was a scam and a report was taken.

August 21, 2019 - 1528 hours

Officers responded to Callaway Court on a burglary alarm activation. Upon arrival officers located an unlocked front door. The home was checked and the homeowner arrived on scene. No signs of criminal activity.



August 22, 2019 - 1019 hours

A resident on Moss Oak Trail reported that a suspicious commercial vehicle was parked in front of her house. Contact was made with the driver who advised he had pulled over to check his phone.

The officer responded to Lakeview Drive and made contact with the resident who advised she had recently sold the vehicle and there had been complication in transferring the title to the buyer. Officers assisted the Sugarcreek Township Police Department with a welfare check on a possible intoxicated male in the area of Kables Mill. The officers located the male lying in a driveway. Officers were able to wake him up and checked his medical condition. The 36-year old male was transported to his home in Dayton.
