### **September 8, 2019 – 2047 hours**

Officers were dispatched to Mill Pond Drive on a possible domestic dispute. Investigation revealed that the residents had been watching a football game and may have been loud which alerted the neighbors. There was no problem.

#### **September 8, 2019 – 2136 hours**

A hit & run accident was reported on South Linda Drive. A vehicle traveling Westbound on South Linda Drive lost control and drove through a yard, striking a parked vehicle. Report taken.

#### **September 8, 2019 – 2326 hours**

Officers responded to West Maple Street on the report of a domestic dispute. Investigation led to the arrest of a 35-year old female from Bellbrook for Domestic Violence and Assault.

## **September 9, 2019 – 0226 hours**

An officer stopped a vehicle on Wilmington-Dayton Road for an equipment violation. Investigation revealed that the 27-year old male driver from Dayton was intoxicated. The suspect was taken into custody and charged with Operating a Vehicle while under the Influence, and No Rear License Plate.

#### **September 9, 2019 – 0530 hours**

A disturbance was reported on Mill Run Lane. Two subjects had been in an altercation with one male refusing to leave the residence. The 25-year old male from Fairborn was issued a written warning for Criminal Trespassing and advised he would be arrested if he returned to the residence.

# **September 9, 2019 – 1800 hours**

A business on West Franklin Street reported high valued merchandise had been stolen during the overnight hours. The case was assigned to a detective.



### **September 10, 2019 – 0555 hours**

An officer responded to West Franklin Street on a residential burglary alarm activation. Investigation revealed that the alarm had been set off by accident.

#### **September 10, 2019 – 2300 hours**

Criminal Damaging was reported on Wilmington-Dayton Road. A speed limit sign had been struck and was separated from its' base. The sign and base were lying in the complainant's yard. The Bellbrook Service Department was dispatched to replace the sign.

## **September 11, 2019 – 1310 hours**

A parking problem was reported at a business on State Route 725. A bicycle had been parked in a handicap space. The bicycle owner was located and told to move it.

## **September 11, 2019 – 1458 hours**

A traffic accident was reported on East Franklin Street. A driver traveling Westbound failed to stop for a vehicle that was stopped in traffic in front of her, causing a collision. The driver at fault, a 17-year old female from Bellbrook was cited into Greene County Juvenile Court for Failure to Maintain Assured Clear Distance.

## **September 11, 2019 – 2104 hours**

A verbal dispute was reported on Lakeview Drive. A 33-year old female had been locked out of a residence with her children by a relative. Prior to the officers' arrival the relative had let all involved parties back into the home. Report taken.

## **September 12, 2019 – 0916 hours**

A resident on West Franklin Street reported that an unknown subject had hacked into his computer during the overnight hours and as a result all files on the computer were encrypted. The hacker demanded money to have the files decrypted. The complainant did not reply or send any money to the hacker. Report filed.



### **September 12, 2019 – 1247 hours**

Officers were requested to perform a welfare check on an intoxicated female on South Lakeman Drive. Upon arrival the officers located a 42-year old female crawling on the ground in her front yard. The female admitted to having smoked marijuana. Family members arrived on scene and the home was checked for any other illegal narcotic substances. Nothing was found. The female was released to the care of her family.

#### **September 13, 2019 – 0815 hours**

A resident on Upper Hillside reported ongoing problems with her neighbor who yells at her every time he sees the complainant outside with her dogs. Extra patrol on Upper Hillside was initiated and a report was taken. The complainant was advised to contact the police department if the situation escalates.

## **September 13, 2019 – 1915 hours**

An officer stopped a vehicle on West Franklin Street for a registration violation. Investigation revealed that the 45-year old male from Centerville did not have a valid driver's license. The suspect was cited into Xenia Municipal Court for Driving under Suspension and Expired Registration.

A 4-year old boy was found walking in the intersection of Wilmington-Dayton Road and State Route 725. The boy had recently walked away from his home on Mill Pond Drive. The child was taken to his home address where his mother was found asleep. The 42-year old female was cited into Xenia Municipal Court for Child Endangerment.
