#### October 13, 2019 – 0618 hours

Officers were dispatched to the area of Wilmington near Centerville Station on a vehicle off the roadway. Investigation revealed the driver swerved off the roadway to avoid a deer.

An officer was dispatched to the area of Clearview and South Linda for a male acting suspiciously while walking in the area. Investigation revealed that the male subject lived in the area and was just on his phone.

#### October 18, 2019 – 2113 hours

# October 19, 2019 – 0034 hours

Officers were dispatched to the area of West Franklin and Millpond for a possible impaired driver. Officers observed a vehicle that pulled off the roadway. After further investigation, the driver was arrested for OVI.

An officer responded to a residence on Lower Hillside for a citizen assist. The homeowner was reporting to be locked out by accident of the residence. Entry into the residence was gained.

#### October 19, 2019 – 1214 hours

Officers responded to the area of West Franklin and South West St. for a 2 car accident. No injuries were being reported. The driver at fault was cited.

# October 19, 2019 – 1401 hours

A 4 car traffic accident was reported on West Franklin Street near North West St. A driver traveling Westbound failed to stop for a vehicle that was stopped in traffic in front of him, causing a collision. This collision caused three vehicles in front to hit each other. The driver at fault, a male from Wilmington was cited into Xenia Municipal Court for Failure to Maintain Assured Clear Distance.

#### October 19, 2019 - 1629 hours

An officer was dispatched to a residence on Clear View for a past theft of lawn equipment from a shed. It is believed that the crime happened a week prior. Investigation pending.

#### October 19, 2019 – 1915 hours

Officers responded to a residence on Old Pepper Bend for an intoxicated male with suicidal thoughts. The Bellbrook medics arrived and transported the male to the hospital.
