March 15, 2020 - 2240 hours

Officer, while on routine patrol, observed a vehicle parked at Magee park after the park had closed. Officer found two juveniles in the vehicle. The juveniles were released to family members and informed about curfew violations.

March 18, 2020 – 0108 hours

Officer received a request to check the welfare of a drive that was observed driving the wrong way on US 42 heading toward Bellbrook. Officer was able to locate the vehicle and check on the driver who was lost.



March 18, 2020 - 1155 hours

Officer was dispatched to a residence on South Lakeman Drive for a suspicious person complaint. The homeowner advised that someone claiming to be with a utility company wanted access to the backyard. Officer confirmed the individual was with the utility company.

March 20, 2020 – 2001 hours

Officer, while on routine patrol, observed people in a vehicle engaged in a loud conversation with some pedestrians. Office spoke with all parties and determined that they knew each other and were meeting up. Officer cautioned them about the social distancing recommendation.

Officer was dispatched to the area of Pinegrove on a noise complaint. Officer found individuals riding a dirt bike in the roadway. Officer advised that the dirt bike cannot be on the roadway and to be considerate about the time of night and the amount of noise being made.
