#### December 29, 2019 - 0055 hours

Officer responded to the area of Bradley Court and Tampico Trail regarding a disturbance/verbal dispute reported by a third party. There was no active disturbance when officer arrived. Officer checked the surrounding area and was unable locate any issues.

# **December 29, 2019 – 0323 hours**

Officer responded to the area of Mill Pond and Old English Circle reference a noise complaint. It was determined that two separate locations had music playing at a level louder than normal. Contact was made with both residents and they were advised to keep the music down.

#### December 29, 2019 – 1807 hours

Officer was requested to assist Sugarcreek Township Police Department in searching a residence due to a front door being left open. Officer helped clear the house, nothing was found out of place.

#### December 29, 2019 – 2244 hours

Officer was dispatched to a business on Lakeman Drive for an intrusion alarm. Officer checked the listed location and found it to be a false alarm.

#### December 30, 2019 – 0400 hours

Officer was dispatched to the area of Wilmington Dayton and Moss Oak Trail to check the roadway for debris. Officer cleared the roadway of trees/debris.

Officer was dispatched to a business on East Franklin Street regarding an intrusion alarm. A door was found unsecured. The business was checked and the keyholder arrived to secure the business.

Officer was dispatched to a residence on West Sudbury Court for a noise complaint. Officer made contact with the resident and advised of the complaint. Resident agreed to keep the noise to a minimum.

# **December 30, 2019 – 0841 hours**

Officer responded to a business on East Franklin Street for an intrusion alarm. Upon arrival, Officer observed an employee opening the business for the day. False alarm.

# December 30, 2019 – 1032 hours

Officer was dispatched to a lockout request. Officer was able to gain entry to the vehicle.

#### December 30, 2019 – 1202 hours

Officer was dispatched to a residence on Hillcrest to check the welfare of animals. Officer responded and found no one home. Officer was able to see some dogs through the window. They did not appear to be neglected. Officer spoke with a neighbor who advised the owner left this morning for work and comes home to care for the animals.

#### **December 30, 2019 – 2039 hours**

Officer was dispatched to a residence on Weller Drive for a report of domestic violence. The investigation revealed that an adult made threats to two family members. Officer issued a charge of Domestic Violence by Threats to this individual.

# **December 31, 2019 – 0005 hours**

Officers were dispatched to the dead-end area of River Birch Court on a report of suspicious activity. Several vehicles were leaving the area as officers arrived. Two vehicles were stopped by officers and the occupants advised they were conducting an experiment and chose this location to be clear of anything. Officers gave them a warning.



# December 31, 2019 – 1620 hours

Officers responded to a residence on North Belleview Drive on a welfare check. A UPS driver made a delivery to this address and found the front door open and dogs from the residence running outside. Officers contacted a resident who was unaware the door was open.

#### **December 31, 2019 – 1657 hours**

Officers were dispatched to the area of Portage Path and South Linda Drive for a dog running at large complaint. Officers were unable to contain the dog and called for Animal Control to respond. The dog was caught by Animal Control.

# December 31, 2019 - 2249 hours

Officers responded to a residence on Sable Ridge Drive regarding an underage consumption complaint. The homeowner advised that he allowed his child to have friends over for a party but was unaware that alcohol would be involved. Once he became aware of this, he notified the police department. Investigation revealed that the juveniles who had consumed alcohol were no longer at the residence and those who remained claimed no knowledge of their names. The parents of the remaining juveniles were notified to pick their children up.

#### January 1, 2020 – 0159 hours

Officer, while on patrol, noticed a vehicle stopping multiple times with hazard lights displayed. The officer pulled in behind the vehicle and found the it was being operated by a designated driver and one of the passengers was ill. Officer checked the driver for impairment and detected no issues. All parties were released with no further issues.

# January 1, 2020 – 0239 hours

Officers were dispatched to the area of Surrey Trail and North Lakeman Drive reference a report of suspicious activity. The area was checked with no signs of criminal activity found. The suspects were gone prior to officers arrival.



# January 1, 2020 – 0300 hours

Officer, while on patrol, observed a vehicle committing traffic violations. Officer conducted a traffic stop and after investigation determined the driver was under the influence of alcohol. The driver was arrested and issued a citation for Operating a Vehicle under the Influence.

Officer was dispatched to a residence on Beechwood Drive. Officer spoke with the resident who wanted advice on a civil matter. Officer directed the resident to the Court for information on the eviction process.

Officer was dispatched to a residence on Jacob Hills Court to check the welfare of a resident. Officer found an individual at this location who was intoxicated and bleeding from the head. A medic was called to transport the resident for medical evaluation.

Officer was dispatched to a residence on South Regent Park Drive reference a custody exchange. Officer spoke with both parties who disagreed about a custody issue. This was determined to be a civil matter.

Officer contact the suspect and discussed the allegations. Both parties were advised to block each other on this social media platform.
