## May 9, 2022 – 0220 hours

An Officer responded to State Route 725 to assist STPD with an investigation and pat down of a female subject.

## May 9, 2022 - 0710 hours

Officers responded with the Medics to Beryl Drive on the report of an unconscious subject. One individual was taken to MVS for further treatment.
