May 22, 2022 – 0100 hours

While on patrol, officers located an open car door on Kensington Drive. Officers contacted the owner and secured the door. No signs of criminal activity.

May 22, 2022 – 0710 hours

Officers assisted with a vehicle unlock on Woodacre Drive. Entry gained.

May 22, 2022 – 1614 hours

Officers responded to Washington Mill Road for two theft from vehicle complaints. In both cases, the vehicles were damaged and purses and other valuables were stolen. The investigation is ongoing.

May 22, 2022 – 1901 hours

Officers responded to a traffic accident on W. Franklin Street involving two motorcycles. No serious injuries were reported and one driver was cited for Failure to Control.

A fraud complaint involving multiple suspicious Amazon packages was reported on Mill Pond Drive. The investigation is ongoing and has been turned over to the Detective Section.

Telecommunications harassment was reported on Shadowleaf Drive. Unknown subjects were threatening the complainant through a chat app.

A domestic disturbance was reported on Brookwood Drive. The parties were separated upon officers arrival. It was determined that the dispute was verbal only and no threats or violence had occurred.

May 25, 2022 – 1105 hours

A welfare check was requested on Pinegrove Drive. The resident checked OK.

May 25, 2022 – 1654 hours

Officers responded to Post to meet with a resident regarding child custody issues. It was determined that this incident is Civil in nature.

May 26, 2022 – 0006 hours

Loud music was reported on Bonniedale Drive. Officers located the source of the noise and they turned the music off without incident.

May 26, 2022 – 1015 hours

A welfare check was requested on Lakeview Drive after a juvenile did not show up for school. Officers located the juvenile, who checked ok, and determined there was no cause for complaint.

A suspicious person was reported on W. Franklin Street. The caller stated the subject was walking in the middle of the road. Officers located the subject walking on the bike path and gave him a ride to the bus stop.

A traffic crash with injuries was reported on Wilmington-Dayton Rd. One driver crossed the center line, causing a head-on crash. Both drivers were taken to the hospital with minor injuries.

May 27, 2022 – 0214 hours

While on patrol, officers located an open door at a business on State Route 725. The business was checked and the door was secured.

May 27, 2022 – 0235 hours

While on patrol, officers located an open garage door at a residence on Barnett Drive. The owner was notified and closed the door.

May 27, 2022 - 1813 hours

A 9-1-1 open line call came from a business on E. Franklin Street. Officers responded to the business and everyone checked OK. Further investigation revealed juveniles had accidently called 9-1-1 from their watches.

A Peace Officer was requested on Knob Hill Drive to stand by for a property exchange.

May 28, 2022 – 0304 hours

Officers attempted to initiate a traffic stop on State Route 725. The suspect refused to stop and attempted to elude officers. The suspect stopped on Pellbrook Farm Drive in Centerville. Further investigation revealed that the driver was suspended and driving with fictitious tags. The subject was also charged with Obstructing Official Business and transported to the Greene County Jail.



May 28, 2022 – 1322 hours

Officers responded to Upper Hillside Drive on a neighbor dispute. The reporting party was concerned that a neighbor was acting suspiciously and coming onto their property. At the request of the reporting party, officers informed the subject to cease communication with the RP and refrain from coming onto the RP's property without permission.
