**July 17, 2022 – 0147 hours**

Officers conducted a traffic stop on Wilmington-Dayton Rd. After speaking with the driver, it was verified that he had an active warrant from OSHP. Further investigation led to the discovery of an open container in the vehicle, as well as suspected drug paraphernalia. The driver was cited for the open container and released to the custody of OSHP. Additional charges are pending.
