A fraud complaint was reported on Kensington Drive. Unknown subjects attempted to make a fraudulent purchase with the complainants credit card number.

Officers were dispatched to Ridgeway Rd. on the report of juveniles driving a golf cart in the roadway. Officers located the juveniles and spoke with the parents and advised it is illegal to drive the golf cart on the road.

The subject was subsequently charged with criminal damaging, OVI and obstructing official business.
