August 7, 2022 – 0057 hours

While on patrol, officers located a suspicious vehicle parked in Magee Park. Officers spoke with the occupants and advised them the park closes at dusk, and they left the area without incident.

The driver exhibited no signs of impairment but was issued a citation for open container and DUS. The driver and occupants waited on a responsible, valid driver to arrive.

While on patrol, officers heard an audible alarm coming from a business on State Route 725. Officers checked the perimeter and requested the owner respond to turn off the alarm.
