December 25, 2022 - 0251 hours

Officers were dispatched to Weller Drive on a noise complaint. The RP stated a car alarm had been going off for an extended period of time. The alarm had been turned off prior to the officers arrival. They checked the area around the vehicle and did not find any signs of criminal activity.
