Fire Chief Jim Neidhard Retiring



In October, Fire Chief Jim Neidhard announced his retirement as of December 31, 2020. This marks the end of a 35-year career. Chief Neidhard began his career in the fire service as a volunteer firefighter at Washington Township in 1985. He began his full-time career in 1990 as a Firefighter/Paramedic at Miamisburg before returning to Washington Township in 1993. He served in various roles during his 21-year tenure at Washington Township and ultimately served as their Deputy Chef. Jim was hired by the City of Bellbrook as the City's second full-time Fire Chief in January of 2014. During his tenure in Bellbrook, the department obtained an ISO rating of 2, which put the department in the top 3% of the nation. He digitized the department's reporting technology, updated all department policies to be in line with best practices, and secured a grant for the department's CPR LUCAS devices. Chief Neidhard also saw the passage of a new levy in 2018, which allowed the increase of staffing to safer numbers. He has overseen numerous equipment and apparatus purchases to provide the de- \sim partment with the tools necessary to provide excellent service to the community. Chief Neidhard has served

Bellbrook well over the last seven years and has forever left his mark on the department and the community, and for that, we thank him and wish him well in his well-deserved retirement!

City Received \$445,571 in Coronavirus Relief Funds

In March of this year, the US Department of Treasury awarded funds to the State of Ohio as part of the CARES Act. The state then funneled monies to Ohio counties, which in turn funneled monies to local governments. There

were three total awards given over the last several months. The total received by the City of Bellbrook was \$445,571. Spending was bound by ever-changing guidance from the state and federal level. Any unused funds by November 20 were to be returned to the distributing county. The City worked hard to identify projects to spend the funding to protect staff and the community from the pandemic. Here are the major spending categories the funds were used for:

Recently Adopted Legislative Items

Fire Station Consolidation Feasibility

In furtherance of our downtown revitalization efforts, the City has given consideration to the feasibility of combining our two fire stations.

The City currently operates two fire stations. Fire Station 1 is located on North West Street and houses the department's offices. Station 2 is located on West Franklin Street and houses typical department equipment and overnight staffing quarters.

Several years ago, the City explored the option of acquiring land to construct a new, combined station. This option did not warrant further consideration, and discussions were discontinued at that time.

As the revitalization effort brought this issue back for consideration, an architectural firm that specializes in fire station design was engaged to further evaluate the combination of stations by expanding Station 2. Preliminary drawings



were prepared for the purpose of cost estimation. The expansion is estimated to cost between \$2.5-\$3.0 million, plus inflation. The expansion of Station 2 costs roughly 30-40% less than a new build.

The expansion would not negatively impact response times or City services.

City Council has not had any additional in-depth discussions regarding the combination but plans to do so in early 2021. No formal decision is expected at that time; rather, the consideration at this time is directed toward future planning purposes.

Police Department

Reporting Our Police Practices to Our Community

As the Bellbrook Chief of Police, I wanted to communicate directly to you, our Bellbrook residents, policing practices that direct our behavior when performing our duties. The Bellbrook Police Department is committed to providing excellent customer service to the citizens of Bellbrook. It is my profound belief that we are here to serve you! We remain devoted to providing the highest level of law enforcement services to our community. This article will demonstrate some of our policies and procedures that govern our behavior and policing practices. —Chief Doug Doherty

<u>Use of Force</u> - Officers receive Use of Force training annually that directs officers as to the appropriate level of force needed in varying situations and retraining on all of the tools and methods of their use. If we have a "use of force" incident, the shift supervisor, Patrol Captain, and Chief of Police will review the force used and ensure it falls within our policies/ procedures and state-mandated guidelines. Officers are given annual refresher training that deals with hand-cuffing and the need to keep people in positions that do not restrict their ability to breathe properly. If we have a "use of force" incident, the shift supervisor, Patrol Captain, and Chief of Police will review the force used and ensure it falls within our policies/procedures and state-mandated guidelines. Officers are given annual refresher training that deals with handcuffing and the need to keep people in positions that do not restrict their ability to breathe properly.

<u>Neck Restraints Policy</u> - The usage of neck restraints or chokeholds are not taught at the Bellbrook Police Department. We do not teach or accept the use of force that deploys any type of neck restraint.

<u>**Training</u>** - Officers are required to meet any State of Ohio training standards in addition to annual firearms and Use of Force training. In 2020, Officers were required to complete training classes dealing with topics such as: "Dealing with Pressurized People," "Implicit Bias Awareness," and "Cultural Awareness."</u>

<u>Crisis Intervention Training</u> – The Bellbrook Police Department has always supported the need for our officers to attend Crisis Intervention Training (CIT). 75% of our officers have received this week-long training, and we will have two attend a class in 2021. CIT training focuses on responding to a multitude of emergency calls that deal with drug abuse or behavioral disorders and using the least amount of force necessary to achieve a positive outcome for all involved.

Body Cameras - The Bellbrook Police Department has worn body-worn cameras (BWC) since 2016. Captain Carmin was

instrumental in our agency starting this program. It has become a popular tool to demonstrate emergency calls and the level of professionalism our officers use to defuse volatile situations. The Patrol Sergeants, Patrol Captain, and Chief of Police all have the ability to review the recordings. Often, we use these as positive examples to validate our responses and training practices.

<u>Staffing</u> - The Bellbrook Police Department has worked hard to create a modern workforce and work environment that is diverse, professional, and attentive to our community's needs.

Ohio Collaborative Law Enforcement Advisory Committee (OCLEAC) -The Ohio Collaborative, a 12-person panel of law enforcement experts and community leaders from throughout the state, established state standards – for the first time in Ohio's history. The Collaborative works closely with partners, including the community and law enforcement agencies, to implement the new standards. All law enforcement agencies are expected

to meet or exceed these new standards to develop policies and procedures to meet these new expectations. The Ohio Office of Criminal Justice Services (OCJS), a division of the Ohio Department of Public Safety, communicated those new standards to Ohio's nearly 960 law enforcement agencies. The Bellbrook Police Department has met past standards and is working to meet the new and on-going standards as they are released by the State of Ohio.

<u>**Complaint Process</u>** - The Bellbrook Police Department remains committed to providing community members several ways to contact the police department to advise us of a complaint or a compliment. All complaints will be given immediate attention and investigated thoroughly. Results will be given to the complainant upon completion of the investigation.</u>

<u>Community Outreach Programs</u> – The Bellbrook Police Department offers a wide variety of Community Outreach Programs that allow community members and their police officers to develop positive contacts. Some of the programs we offer are Neighborhood Walks, Coffee with A Cop, Greet children at school every morning, Cones for Kids (which officers pass out a coupon to the Dairy Shed if we see children in the community), National Night Out, Bike Patrols, to name just a few. We are always looking for fresh ideas in this area. Please contact us if you have an idea for a community outreach program.










Service Department

About the Service Department

The Service Department operates and maintains the water system serving the city and part of Sugarcreek Township. Currently, the city has one employee with a Class 2 Operator's License and five employees with a Class 1 Operators License. The Ohio EPA requires the city to have a minimum of one employee with a Class 1 Operator's License. The water system serves over 9,000 people in the city and township. The department also maintains city streets, storm sewers, and city buildings.

North Main Parking Striping

This fall, during the annual street re-striping, the Bellbrook Service Department added parking lines on North Main Street to help indicate available parking spaces. With this addition, we hope to help emphasize the abundance of parking in our downtown area. Our goal is to continue to



work towards creating small improvements such as this that complement our downtown. If you have suggestions, we are always open to hearing them. Please call **937-848** -**4638**. In 2019, street striping along Franklin Street also emphasized parking in that area, which has been well received and utilized regularly.

Holiday Trash Pickup Schedule

During the Christmas and New Year's holidays, trash will be delayed by one day. Trash will be picked up on Saturday those two weeks. The specific dates for trash and recycling pick-up are November 28th due to

Thanksgiving, Saturday, December 26th due to Christmas, and Saturday, January 2nd, 2021, due to New Year.



North Belleview Before-During-&-After





On March 20th, 2020, a severe storm brought heavy rains that flooded the area and washed away the bridge on North Belleview Drive. Bids were accepted in late-June/July. On July 21, 2020, the City was notified of being awarded



in Ohio Public Works Commission Emergency Program funding. \$347,000 was requested to cover the construction and contingency costs associated with the North Belleview Drive project, which suffered a culvert collapse. This funding equates to 80% of the total project costs. The project was completed and open for traffic on October 19th, 2020, almost two weeks ahead of schedule.

Planning & Zoning

Tentatively in spring/summer of 2021, FEMA will be finalizing the Flood Plain maps changes, which is how insurance rates are determined for structures that reside in the Flood Plain. These maps are used by community officials, mortgage lenders, insurance developers, and builders. They are essential to be aware of when making any improvements on your property or when purchasing/selling a property. To view the updated map compared to the current map, please visit msc.fema.gov/portal.

Fire Department

It is fun to decorate for the winter holidays, but holiday decorations can increase your risk for a home fire. As you deck the halls this season, be fire smart.

- More than half of the home decoration fires in December are started by candles.
- More than 1/3 of home decoration fires are started by candles.
- The top 3 days for home candle fires are Christmas Day, New Year's Day, and New Year's Eve.
- Keep candles at least 12 inches away from anything that burns.
- A heat source too close to the Christmas tree causes 1 in every 4 winter fires.
- Read manufacturer's instructions for the number of light strands to connect.
- Make sure your tree is at least 3 feet away from heat sources like fireplaces, radiators, space heaters, candles, or heat vents. Also, make sure your tree does not block exits.
- Get rid of your tree after Christmas or when it is dry.
