Mrs. Middlestetter was absent. Mr. Martin moved to excuse Mrs. Middlestetter. Mr. Edwards seconded the motion. The Clerk called the roll: Mr. Martin, yes; Mr. Edwards, yes; Mr. Greenwood; Mrs. Seger-Lawson, yes; Mr. Schweller, yes; Mayor Baird, yes. The motion carried 6-0.

This is a summary of the City Council meeting held on Monday, July 11, 2016. Mayor Baird called the meeting to order at 7:00 pm and the Clerk called the roll.

After polling members of City Council, as there were no corrections or additions to the **regular meeting minutes of June 27, 2016**, Mayor Baird declared the minutes approved as written.

MAYOR'S ANNOUNCEMENTS/SPECIAL GUEST

Mayor Baird thanked Mr. Martin for serving on City Council. This is Mr. Martin's last meeting as he is moving out of Bellbrook and is not eligible to serve on Council. Mayor Baird said the City is accepting applications for the vacancy on Council. Information is available on the City's website.

Mike Sabin came to Council to speak about the Family Resource Center. Greene County has withdrawn all budgetary support for the Family Resource Center. He is currently leading a Task Force to save the center. Mr. Sabin said the Family Resource Center will operate under the umbrella of the Community Wellness Coalition. This will allow the Family Resource Center to begin to do fundraising and move forward with the day to day operations of the center. Mayor Baird told Mr. Sabin that once the Family Resource Center is re-organized come back to Council with a formal request.

Next Mr. Sabin shared an upcoming activity of the Bicentennial Celebration. A band concert and ice cream social will be held at the Bellbrook Middle school this Saturday, July 16th from 1:00 to 7:00 pm.

Chris Ewing from the Bellbrook Sugarcreek Area Chamber of Commerce came to update Council on some local items. A keepsake mug in celebration of Bellbrook's Bicentennial is available for purchase at the Chamber office or at the band concert this weekend. Ms. Ewing mentioned that new maps and directories are available at the Chamber and also the City Administration building. The Chamber's annual golf outing is scheduled for August 25th at Sugar Valley Golf Club. Ms. Ewing said Gardinas Pizza opened up in Bellbrook across for the City Administration Office. They have authentic Italian pizza and they do deliver. Next, Ms. Ewing talked about the Presidential debate that is coming to

Greene County on September 26th. It is a big event and Ms. Ewing said we want all those coming to the debate to spend their money in Greene County. With the mention of the Presidential debate on September 26th, Mayor and Council decided to cancel the Council meeting that was scheduled for that evening.

PUBLIC HEARING OF ORDINANCES

Mrs. Seger-Lawson read **Ordinance 2016-6-** An Ordinance Amending Part Six – General Offenses Code of the Bellbrook Municipal Code. All code sections that were duplicates of the Ohio Revised Code were eliminated. The proposed changes have been reviewed by the Police Department and the Prosecuting Attorney. Being a public hearing, Mayor Baird opened up for public comments. Seeing no comments from the public the Mayor closed the public hearing and asked for a motion

Mrs. Seger-Lawson made a motion to adopt Ordinance 2016-6 Mr. Schweller seconded the motion. The Clerk called the roll: Mrs. Seger-Lawson, yes; Mr. Schweller, yes; Mr. Edwards yes; Mr. Greenwood, yes; Mr. Martin, yes; Mayor Baird, yes. The motion carried 6-0.

Mr. Schweller read **Ordinance 2016-7**. An Ordinance Authorizing the City Manager/Finance Director to Submit the Tax Budget for Fiscal Year 2017 to the Greene County Auditor. This ordinance authorizes the submission of the 2017 tax budget as required by the Greene County Auditor. The tax budget is the first step in the process for the allocation of local government funds and certification of property tax levies. Being a public hearing, Mayor Baird opened up for public comments. Seeing no comments from the public the Mayor closed the public hearing and asked for a motion

Mr. Schweller made a motion to adopt Ordinance 2016-7. Mr. Martin seconded the motion. The Clerk called the roll: Mr. Schweller yes; Mr. Martin, yes; Mr. Edwards, yes; Mr. Greenwood yes; Mrs. Seger-Lawson, yes; Mayor Baird, yes. The motion was carried 6-0.

Mr. Greenwood read **Ordinance 2016-9** An Ordinance Amending Article 3, Section 3.02 "Definitions" of the City of Bellbrook Zoning Code to Revise the Definition of "Kennel.". This ordinance amends the definition of a kennel in the Zoning Code by removing the word "training" from the definition. A proposed new business in downtown Bellbrook plans to offer dog training as part of their service. Being a public hearing, Mayor Baird opened up for public comments. Seeing no comments from the public the Mayor closed the public hearing and asked for a motion

Mr. Greenwood made a motion to adopt Ordinance 2016-9. Mrs. Seger-Lawson seconded the motion. The Clerk called the roll: Mr. Greenwood yes; Mrs. Seger-Lawson yes; Mr. Edwards yes; Mr. Martin, yes; Mr. Schweller, Mayor Baird, yes. The motion carried 6-0.

INTRODUCTION OF ORDINANCES

Mr. Edwards read **Ordinance 2016-8.** An Ordinance Granting an Easement to the State of Ohio, Department of Transportation for Improvements to the State Route 725 Road Embankment along Sackett-Wright Park. This ordinance will grant an easement to ODOT for a storm water drainage project

to improve the embankment of State Route 725 along Sackett-Wright Park. ODOT has offered to pay \$6,350 for the 0.635 acre easement. This ordinance is a modification of the ordinance that was introduced at the June 27th meeting. The City owns the land but the Park District maintains the land. The allocation of the payout from ODOT changed. This ordinance is scheduled for public hearing on August 8th.

Mr. Edwards made a motion to re-introduce Ordinance 2016-8. Mr. Greenwood seconded the motion. The Clerk called the roll: Mr. Edwards, yes; Mr. Greenwood, yes; Mr. Martin, yes; Mrs. Seger-Lawson, yes: Mr. Schweller, yes; Mayor Baird yes. The motion carried 6-0.

Mr. Schweller read **Ordinance 2016-10** An Ordinance Amending Ordinance 2015-16 to Adjust the City of Bellbrook Appropriations to Reflect Additional Costs in some Line Items and Reduced Costs in other Line Items. Mr. Schweller said the biggest reduction comes from capital projects. Mr. Schlagheck agreed and said that the capital projects came in under budget. Mr. Schlagheck also said that the arrangement with the City's Prosecuting Attorney accounts for some of the reduction too.

Mr. Schweller made a motion to introduce Ordinance 2016-10. Mr. Martin seconded the motion. The Clerk called the roll: Mr. Schweller, yes; Mr. Martin, yes; Mr. Edwards, yes, Mr. Greenwood, yes; Mrs. Seger-Lawson, yes; Mayor Baird, yes. The motion carried 6-0.

RESOLUTIONS

Mr. Martin read **Resolution 2016-V.** A Resolution Authorizing the City Manager to Adjust the Pay Scales of City Positions not Covered by a Collective Bargaining Agreement. The proposed increase of 2% was reviewed and approved by the Finance Committee. Mr. Schlagheck said the Police Contract will enter into its third and final year and will grant a 1% increase on August 1st. The Fire contract also will enter into its third and final year and will grant a 1.5% increase effective December 1st.

Mr. Martin made a motion to adopt Resolution 2016-V. Mr. Edwards seconded the motion. The Clerk called the roll: Mr. Martin, yes; Mr. Edwards yes; Mr. Greenwood, yes; Mrs. Seger-Lawson, yes; Mr. Schweller, yes; Mayor Baird yes. The motion carried 6-0.

CITY MANAGER REPORT

Mr. Schlagheck said on Tuesday, August 2nd, the Police Department will be hosting a National Night Out. It will be held at the Police Department from 6-8 pm. Police cruisers will be on display and tours of the Police Department will be offered. Hot dogs will be available too.

The annual paving program is scheduled to start on July 18th. The work is primarily around Stephen Bell elementary and also includes North Regent Park Drive and Sudbury Court.

The water tower repainting project has begun. They are currently painting the inside of the tower. The Contractor has until August 12th to complete the project.

Mr. Schlagheck said the price for road salt this year will be just under \$55.00 per ton. This will save the City about \$6,000 in 2017.

Lastly, Mr. Schlagheck said the Street Light Conversion to LED has started. They are currently in the downtown area.

<u>Finance/Audit:</u> Mr. Schweller commented on the quarterly financial update. Revenue is flat with slight increases in EMS and tap in revenues. He said the City is keeping tight to the budget. He also said the City's budget process is second to none.

Ordinance No. 2016-8

An Ordinance Granting an Easement to the State of Ohio, Department of Transportation for Improvements to the State Route 725 Road Embankment along Sackett-Wright Park.

WHEREAS, the City of Bellbrook owns certain parcels of land adjacent to State Route 725; and

WHEREAS, the State of Ohio, Department of Transportation has initiated a project to protect the State Route 725 roadway embankment from erosion created by Sugar Creek; and

WHEREAS, the State of Ohio, Department of Transportation, requires an easement of 0.635 acres to complete this project; and

WHEREAS, the State of Ohio, Department of Transportation, has offered to pay the City of Bellbrook \$10,925 for this easement.

Now, Therefore, the City of Bellbrook Hereby Ordains:

- Section 1. That the City of Bellbrook grants the easement, attached hereto, to the State of Ohio, Department of Transportation.
- Section 2. That the City Manager is hereby authorized to execute the attached easement and such other related documents as may be required.

EASEMENT

Know All Men By These Presents That:City of Bellbrook, Greene County Ohio, the Grantor(s) herein, in consideration of the sum of \$10,925, to be paid by the State of Ohio, Department of Transportation, does hereby grant, bargain, sell, convey and release to the State of Ohio for the use and benefit of the Department of Transportation, the Grantee herein, an easement, which is more particularly described in Exhibit A attached hereto, within the following described real estate:

And the said Grantor(s), for its self and its successors and assigns, hereby covenants with the said Grantee, its successors and assigns, that it is the true and lawful owner(s) of said premises, and lawfully seized of the same in fee simple, and has good right and full power to grant, bargain, sell, convey and release the same in the manner aforesaid, and that the same are free and clear from all liens and encumbrances whatsoever, except: (a) easements, restrictions, conditions, and covenants of record; (b) all legal highways; (c) zoning and building laws, ordinances, rules, and regulations; and (d) any and all taxes and assessments not yet due and payable; and that Grantor(s) will warrant and defend the same against all claims of all persons whomsoever.

The property conveyed herein to Grantee is being acquired for one of the statutory purposes the Director of Transportation may acquire property under Title LV of the Revised Code, such as but not limited to those purposes enumerated in Sections 5501.31 and 5519.01 of the Revised Code.

Grantor(s) has a right under Section 163.211 of the Revised Code to repurchase the property conveyed herein if Grantee decides not to use the property for the purpose stated above and Grantor(s) provides timely notice of a desire to repurchase; provided however that such right of repurchase is subject to the authority of the Director of Transportation to convey unneeded property pursuant to Section 5501.34 (F) of the Revised Code. The price to be paid upon such repurchase shall be the property's fair market value as determined by an independent appraisal made by an appraiser chosen by agreement of the parties or, if the parties cannot agree, an appraiser chosen by the court. The within right of repurchase shall be extinguished if any of the following occur: (A) Grantor(s) declines to repurchase the property; (B) Grantor(s) fails to repurchase the property within sixty days after Grantee offers the property for repurchase; (C) Grantee grants or transfers the property to any other person or agency; or (D) Five years have passed since the property was appropriated.



Extra Duty Employment Agreement For Bellbrook Police Officers

This agreement is made this	day of	<u>, 2016</u> by and between
the City of Bellbrook, hereafter referred	d to as the "City,	" and the Bellbrook-Sugarcreek
Local School District, hereafter referred	d to as the "Distr	rict".

WHEREAS, the District wishes to utilize the services of City police officers in a security assignment, specifically, security for the 2016 Fall Bellbrook High School (home game) football season.

Now, therefore, in consideration of the mutual promises contained herein:

1. Scope of the Agreement

This agreement covers the 2016 Fall Bellbrook High School (Home game) football season from the first home football game in August 2016 until December 2016. Hours of the assignment will be from 1830 to 2130. (Additional time may be spent after the event, in crowd and traffic control). Additional services may be at the request of the District or in the discretion of the City. Three officers will be assigned to each game, if available. The District may request additional officers, if necessary.

2. Enforcement

Officers employed in an extra-duty police-related capacity shall be responsible for the enforcement of City Ordinances, as well as State and Federal Statutes. The District may provide general instructions and direction to City law enforcement personnel so engaged as to the performance of the agreed to police services, however, City law enforcement personnel shall at all times be bound by the Rules, Regulations and Policies of the City of Bellbrook Police Department.

3. Uniform

Officers shall wear the complete uniform of the Bellbrook Police Department and be responsible for completing the appropriate reports and forms necessary to conclude an incident when engaging in extra duty police-related employment unless directed to the contrary by a police supervisor.

4. Supervision

The Bellbrook Police Department on-duty supervisor has the responsibility to oversee the activities of officers engaged in extra duty police-related employment during their respective tour of duty. Whenever more than four (4) officers are required for the same

time at the same extra duty place of employment, a supervising officer, if available, will be assigned for supervision purposes and compensated as provided in paragraph six (6).

5. Release from Service

In the event of a city emergency requiring the services of any extra duty police officer employed by the District, the District agrees that such officer will be released immediately from the extra duty employment.

6. Cost of Services

The District agrees to pay the City of Bellbrook a flat rate of \$120.00 per officer per night.

7. Hold harmless

The District shall indemnify, hold harmless and defend the City, its officers, employees, agents and volunteers against any and all liability, loss, costs, damages, expenses, claims or actions, including attorney's fees which the City, its officers or employees may hereafter sustain, incur or be required to pay, arising wholly or in part due to any act or omission of the District, its agents, servants or employees, in the execution of performance of this contract.

The Bellbrook Police Department of the City of Bellbrook will not be held liable in the event officers cannot be scheduled or provided for the work/event(s) requested.

The District shall secure and maintain, during the period of the agreement, commercial general liability insurance which will protect it and the City from claims for bodily injury, death, property damage or personal injury which may arise from any act or omission of the District, its agents, servants, or employees in the performance of this agreement. The District shall provide the City a Certificate of Insurance showing evidence of such coverage.

8. Invoice

The City shall deliver to the District a monthly invoice for the cost of City law enforcement personnel provided under this Agreement. The District shall make payment to the City in the full amount of such invoice no later than thirty (30) days from the date of invoice.

9. Workers' Compensation

While any City of Bellbrook police officer is working for the District as set forth in this Agreement, the City of Bellbrook will provide the officer with insurance coverage through the State of Ohio Bureau of Workers' Compensation.
