Ms. Dodd said the fire fund levy passed on May 8^{th.} She thanked everyone that got out and supported the levy. Ms. Dodd met with Chief Neidhard to plan how to move forward. She said there is enough room in the budget to allow for those things to happen with minimal impact due to a vacancy in the department.

Ms. Dodd said Little Sugarcreek continues to be monitored by our service department. The road is on the schedule to be paved. Dale Wilson called the paving contractor to see where we were on the schedule and they said they did not plan to be in Greene County until August. The contractor said they could see what they could do to get us on the schedule sooner. Service Director Dale Wilson will contact them again next week for an update

Ms. Dodd said the contractors that are doing the Upper Hillside Water Main project have been off site for the last couple of weeks to finish another job. She said they will be back on the job this Wednesday to start making the connections to the residences.

Ms. Dodd said the community input survey is now closed. There were 120 responses. The results will be tabulated and presented to the Planning Board to determine how to move forward on the update to the Comprehensive Plan. Ms. Dodd said she is anxious to move forward on the update to the Comprehensive Plan.

Next, Ms. Dodd spoke about the summer meeting schedule. Mayor Baird asked Council members to email Jami with any conflicts with the meeting dates. Mayor Baird said the next Council meeting falls on Memorial Day so we will not have another meeting until June 11th

Mr. Greenwood asked Ms. Dodd if she has thought about a permanent fix for Little Sugarcreek Rd. and also funding for the project. Ms. Dodd said it is something she has spoken with the Service Director about. She said the Service Director's assessment of the road is that it is okay for now. They still walk the road twice a week to monitor it. Ms. Dodd said a long term solution is something that the city is going to work towards. She said she has heard a lot of big numbers assigned to this project. Mayor Baird said that funding would probably come from Ohio Public Works funds and or Miami Valley Regional Planning Commission funds.

Mr. Schweller asked Ms. Dodd about the audit. She said she has not been in contact with them since she has started. She said that Mr. Schlagheck has received the last calculation for the financial statements and he would be submitting those soon.
