## City of Bellbrook Ordinance No. 2018-9

An Ordinance Amending Ordinances 2017-14 and 2018-5 to Adjust the City of Bellbrook Appropriations for 2018 to Reflect Additional Costs in some Line Items and Reduced Costs in other Line Items and Declaring an Emergency.

WHEREAS, the City of Bellbrook adopted the 2018 annual budget based on the best information available at the time; and

WHEREAS, additional costs have or will occur in some line items and reduced costs are projected in other line items which requires the amendment of various appropriation levels; and

WHEREAS, this ordinance is presented as an emergency to ensure that current budget authorizations are not exceeded.
