#### January 29, 2023 – 1942 hours

A welfare check was requested on Sugar Run Trail. After speaking with the resident, it was determined that further evaluation was needed and officers called for medics to transport the resident to MVS.

#### January 29, 2023 – 2324 hours

Officers were dispatched to Liam Court for a possible domestic dispute. Upon arrival, officers separated the parties and determined that nothing physical had occurred, but there were threats of violence made. Officers placed one subject under arrest for DV by Threats and transported them to the Greene County Jail without incident.

#### January 30, 2023 – 0550 hours

A suspicious person was reported at a business on State Route 725. Officers located the individual and determined there was no cause for complaint.

#### **January 30, 2023 – 1305 hours**

Officers were dispatched with the Medics to W. Franklin Street on an unresponsive subject. The individual was pronounced deceased on arrival. No foul play is suspected.

### January 30, 2023 – 1834 hours

Officers were dispatched to Firebird Drive on an unwanted subject refusing to leave the property. When officers arrived, the subject left the area without incident.

# February 3, 2023 - 0112 hours

Officers assisted STPD in locating a missing juvenile. The juvenile was later located outside of Bellbrook in Sugarcreek Township.

# February 3, 2023 - 0829 hours

Criminal Damaging was reported on Locus Bend Drive. Unknown subjects damaged a community mailbox in an attempt to open it. Officers notified the Postmaster of the damage.

# February 3, 2023 – 1445 hours

Officers responded to Washington Mill Road on a suspicious vehicle complaint. Officers located the vehicle and determined they were contractors working on a house in the area. No cause for complaint.



### February 4, 2023 - 1132 hours

Officers responded to Callaway Court on a possible domestic disturbance. When officers arrived, both parties were separated and cooperative. It was determined that no violence or threats of violence were made and the dispute was verbal only.
