February 5, 2023 – 1224 hours

Officers were dispatched to Hess Road on a possible domestic dispute. It was determined this dispute was verbal only involving the ownership of a vehicle. The vehicle was left with the legal owner and the parties were advised to separate.

February 5, 2023 – 1902 hours

A possible OVI driver was reported on W. Franklin Street. Officers were able to locate the vehicle in the area of South Linda Drive and observed the vehicle travel outside of its lane. After speaking with the driver, officers determined there were no signs of intoxication and issued a verbal warning for the lane violation.

February 5, 2023 – 1911 hours

Officers responded to a business on W. Franklin Street on a disorderly persons report. The complainant states customers became aggressive and disorderly and were asked to leave the store after leaving a mess for employees to clean up. The investigation is ongoing.

February 6, 2023 – 1237 hours

Officers were dispatched to Periwinkle Drive on a possible domestic dispute. Officers determined that there was evidence of domestic violence by threats. Officers were able to locate the suspect at an address in Kettering. He was placed under arrest and transported to the Greene County Jail without incident.
