March 5, 2023 – 0022 hours

A possible domestic dispute was reported on Hillcrest Drive. Initially, Officers were told that no threats or physical violence had occurred. After further investigation, it was determined that one party did threaten the other party. This resulted in the subject being charged with Domestic Violence by Threats and Aggravated Menacing. March 5, 2023 – 1642 hours

Officers responded to Vineyards Way on the report of a subject taking large boulders from the community pond. Officers located the subject and advised him that he was not permitted to take the rocks.

March 5, 2023 – 1900 hours

Officers were dispatched to a business parking lot on State Route 725 on the report of a private property hit-and-run. Unknown subjects hit the complainants vehicle while it was parked and damaged the mirror.

March 6, 2023 – 1520 hours

A welfare check was requested on Eckworth Drive. All residents checked OK.

March 6, 2023 – 1934 hours

Officers conducted a traffic stop on Wilmington Dayton Road after observing that the plates did not match the vehicle. Further investigation led to the driver being cited for DUS and fictitious registration.

March 6, 2023 – 2045 hours

Officers were dispatched to Bellecrest Court on the report of a possible domestic dispute. After talking with both parties involved, it was determined that there was a verbal argument, however, no threats or acts of violence occurred.



March 7, 2023 – 0854 hours

Officers assisted with a vehicle lockout on Polo Trace Drive. Entry gained.

March 7, 2023 – 0919 hours

Identity theft was reported on N. Main Street. Unknown subjects opened a Verizon account in the complainants name.

March 7, 2023 – 0942 hours

Officers were dispatched to Bellemeade Drive on the report of a theft from a vehicle. Sometime overnight, unknown subjects entered the complainants unlocked car and removed various belongings and money. The investigation is ongoing.

March 7, 2023 – 2004 hours

Officers were dispatched to W. Franklin Street on a found dog. Officers were able to return the dog to its owners and issued a verbal warning for dog at large.

March 8, 2023 – 1931 hours

Officers responded to Belleview Drive on the report of a traffic crash. A driver was backing out of their driveway and hit an oncoming vehicle. One driver was cited for improper backing.

March 8, 2023 – 2232 hours

A possible missing adult was reported on Kensington Drive. With the help of multiple jurisdictions, the subject was located safe in Clark County and it was determined they had likely suffered a medical emergency and became lost.

March 10, 2023 – 1338 hours

Officers responded to Marcia Drive on a request to speak with an officer. It was discovered that the subject officers were speaking with had an active warrant out of Springboro for a TPO violation. Officers took the individual into custody and met with Springboro PD to transfer custody.



March 11, 2023 – 0234 hours

Officers were dispatched to Mill Run Lane to assist OSP with a possible intoxicated driver.

March 11, 2023 – 1136 hours

A Peace Officer request was made on Hillcrest Drive. Officers stood by for a property exchange.

March 11, 2023 – 1350 hours

Officers responded to a business on W. Franklin Street for a person acting suspiciously. Officers located the subject and after speaking with them, determined they may be suffering a medical emergency. Officers called for Medics, who transported the individual to MVS for further evaluation.

March 11, 2023 – 1524 hours

Officers responded to S. Lakeman Drive on a possible domestic dispute that occurred earlier in the day. It was determined that no physical violence had occurred, and the parties separated prior to contacting the police.

March 11, 2023 – 2242 hours

Officers were dispatched to Liam Court on a welfare check after receiving a 9-1-1 hang-up. Officers spoke with both residents and determined that there may have been a dispute, but no violence or threats had occurred.
