A suspicious person was reported on W. Franklin Street. Officers searched the area, but the subject was GOA.

Officers conducted a traffic stop on Washington Mill Rd. After speaking with the occupants, officers suspected drug activity and confiscated drug paraphernalia from the vehicle. A verbal warning was given for lane violations and additional drug charges are pending lab results.
