April 14, 2024 – 0252 hours

Officers assisted STPD with a suspicious person on Surrey Trail. After speaking with the subject, officers learned that they were in possession of property that was stolen out of a vehicle on Bledsoe Drive. The property was returned and the subject was charged with theft.

April 14, 2024 – 1304 hours

Officers were dispatched to E. Sudbury Ct. on a neighbor dispute.

April 15, 2024 – 0034 hours

Officers responded to Beryl Drive to attempt to locate an individual for Texas State Police. Officers contacted the current resident, who advised that subject no longer lived there.

April 15, 2024 – 0255 hours

Officers assisted a motorist with a disabled vehicle on SR 725.

April 15, 2024 – 0535 hours

Officers assisted the medics on W. Maple Street.

April 15, 2024 – 1420 hours

Officers responded to the Montgomery County Jail to take custody of a subject wanted on a felony Bellbrook warrant. The subject was transported to the Greene County Jail without incident.

April 15, 2024 – 1802 hours

A welfare check was requested on S. East Street after a neighbor reported that they heard a scream. Officers searched the area but were unable to locate anyone in distress.



April 16, 2024 -1017 hours

Officers were dispatched to Possum Run Road on the report of a young child outside unattended. Officers were able to quickly return the child to their residence.

April 16, 2024 – 1217 hours

Officers spoke with a resident on Old English Circle regarding a fraud complaint. Unknown subjects fraudulently accessed the victims bank account.

April 16, 2024 – 1753 hours

Officers assisted a motorist with a disabled vehicle on Wilmington-Dayton Rd.

April 17, 2024 – 1723 hours

April 18, 2024 – 1041 hours

Officers responded to Lakeview Drive on a parking complaint. No violations were observed.

A parking complaint was reported on Regent Park Drive. Officers determined there was no parking violation.

Officers were dispatched to Caudell Drive on a Peace Officer standby. While inside the residence, officers observed suspected narcotics and requested the assistance of the county task force. The investigation is ongoing.

April 18, 2024 – 2311 hours

A dog was found running loose on Upper Hillside Drive. Officers were able to catch the dog and later reunite it with its owner.
