Officers were dispatched to State Route 725 for a loose dog. Officers were able to catch the dog and locate the owners.

Officers assisted the medics with a patient with an illness on Cedar Court.

Officers assisted AES with traffic control on Wilmington Dayton Road for downed power lines.

June 11, 2024 – 1011 hours

Officers were dispatched to W. Franklin Street to check the welfare of dogs reported to be outside without water. Officers determined there was no problem and the complaint was unfounded.

The driver was transported to the Greene County Jail without incident.
