July 14, 2024 – 0200 hours

Officers were dispatched to Upper Hillside Drive on a domestic dispute. After speaking with the parties, it was determined the dispute was verbal only and no threats or violence had occurred. The parties agreed to separate for the night and no further calls were received.

July 14, 2024 – 0317 hours

Officers conducted a traffic stop on Wilmington-Dayton Road after observing several equipment violations. After further investigation, the driver was cited for OVI. Officers also recovered suspected drugs from the subject. Additional charges are pending.

July 14, 2024 – 2311 hours

Officers responded to a business on State Route 725 for an alarm drop. Confirmed FA.

July 15, 2024 – 0400 hours

Officers were dispatched to Sable Ridge Drive on a residential alarm. Officers spoke with the homeowner and confirmed it was a FA.

July 15, 2024 – 1143 hours

Officers were dispatched to S. West Street on a parking complaint. Officers determined the vehicle was parked on private property and permitted to be there.
