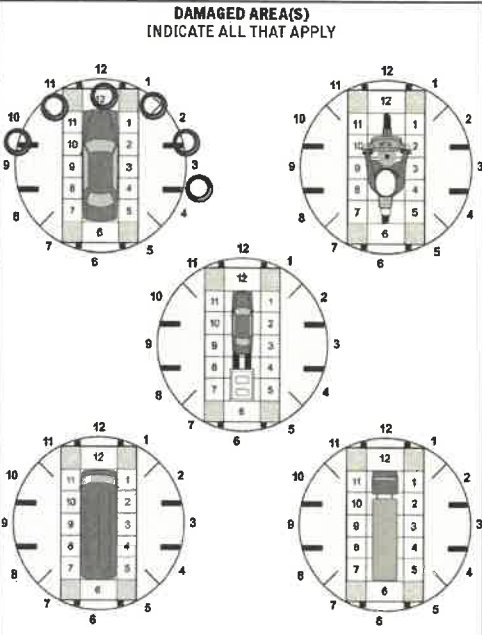

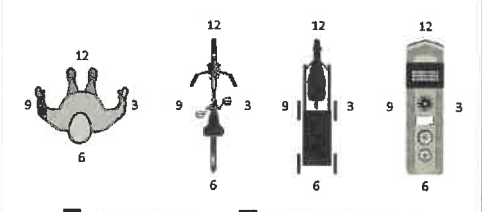

On Wednesday, November 27, 2024, Ofc. Bennington and I responded to Bellbrook Cemetery, 3939 Upper Bellbrook Rd, for a crash with unknown injuries.

Upon arrival, the Bellbrook Fire Department was on the scene with the female driver. When assessing the scene, Bellbrook Fire Chief Bizzaro, stated that after talking with the female driver, she was out of the vehicle, never placed the car in park, and exited the vehicle with the parking brake on. The female driver could not release the rear hatch and released the parking brake. The car jumped forward, heading two headstones, and redirected after contact with the headstones towards the backyard of 256 Pinegrove Dr. After following the vehicle path that the vehicle created with its wheels, the car went under the fence of the cemetery and then went through a storage shed in the backyard of 256 Pinegrove Dr.

Ofc. Bennington advised that when speaking with the female driver, Maureen Read, she thought she put the vehicle in park before getting out. Once the car jumped and started moving forward, Maureen stated that she attempted to stop the vehicle but could not. Maureen advised that she was able to wave someone down to notify the authorities.

I contacted the neighbor across the street from 256 Pinegrove Dr. The neighbor mentioned that she usually babysits the residence's dog, but the owner took the dog with them out of town this time. I asked if the neighbor could make contact with the resident. I spoke with the homeowner, Aaron Lawrence, and relayed information that a vehicle from the cemetery had crashed into his storage shed. Aaron stated that he would be out of town for 6 weeks for work. I advised Aaron that I would be providing my business card to his neighbor, to have him send me his information, and that I would provide the policy number from the driver of the vehicle when possible. Aaron's contact information is (937) 409-2222.

Ofc. Bennington made contact with Bellbrook Cemetery maintenance about the two damaged headstones. Tim Lee (937) 287-3374 advised that he will provide a price on the headstones on Monday, December 2, 2024.

Maureen's vehicle was towed by Hollis towing. Maureen requested the vehicle be taken to Voss Chevrolet on Loop Rd in Centerville, OH.

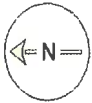

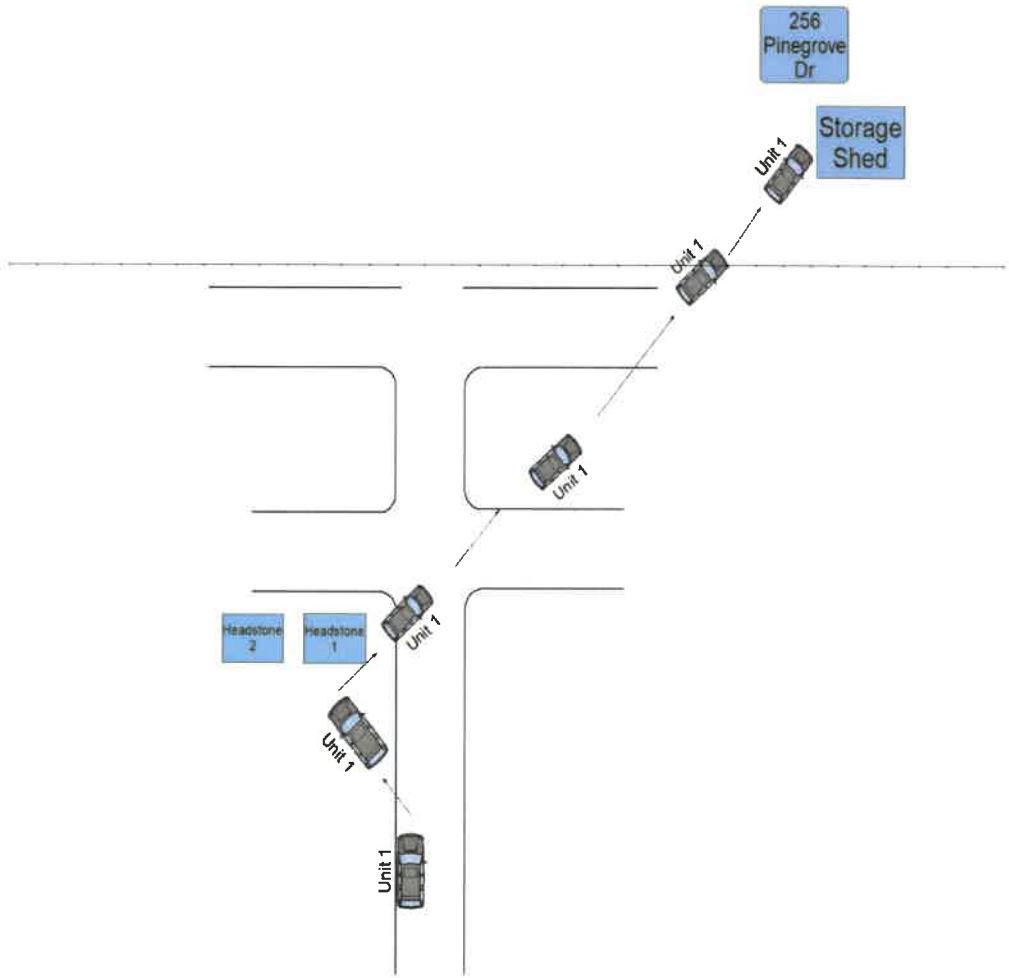
